Sir, With due respect, I am producing herewith the arrested accused persons namely (i) Montu Majumdar (36), S/o- Lt. Rajen Majumdar of Surja Sen Colony, Block-C, PS- NJP, Dist- Jalpaiguri, (ii) Bablu @ Poltu Roy (32), S/o- S/o- Lt. Nirmal Roy of Surja Sen Colony, Block-E, PS- NJP, Dist- Jalpaiguri, (iii) Sanjay Roy @ Laden (22), S/o- Montu Roy of Shanti Para, PS-NJP, Dist.- Jalpaiguri and (iv) Raj Chowdhury (22), S/o- Subal Chowdhury of Maharaja Colony, Near Bishal Mega Mart, W/No. 4, PS- Siliguri, Dist- Darjeeling and the following articles under seizure:-

1. One iron rod measuring 30 cm in length, one screw driver from the possession of Montu Majumdar.

2. One wrench from the possession of Bablu @ Poltu Roy.

3. One bhojali, one torch light from the possession of Sanjay Roy.

4. One hacksaw blade from the possession of Raj Chowdhury.

I, SI Samik Paul of New Jalpaiguri PS, Siliguri Police Commissionerate beg to state that on 30.11.2023 at 00.05 hrs, I received a secret source information that a gang of miscreants assembled at More Bazar Kishore Sangha Club, PS- NJP, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity at Surja Sen Colony area. Accordingly, I informed the fact to you and diarized the matter vide NJP PS GDE No- 1337 Dated-30.11.2023. As per your kind order at 00.15 hrs, vide NJP PS GDE No. 1338 Dated- 30.11.2023, myself along with C/152 Abdul Kayum Mia, C/453 Uttam Dey, C/1044 Hari Kherwar all are of NJP PS, SPC left for More Bazar Kishore Sangha Club, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. On 30.11.2023 at about 00.30 hrs we arrived at More Bazar under NJP PS. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled in a dark place behind Kishore Sangha Club at More Bazar, PS- NJP, Dist- Jalpaiguri and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 04 (four) persons of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity in a house at Surja Sen Colony area. They also stated that others 06/08 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 04 (four) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 00.45 hrs to 01.25 hrs on 30.11.2023.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Montu Majumdar (36), S/o- Lt. Rajen Majumdar of Surja Sen Colony, Block-C, PS- NJP, Dist- Jalpaiguri, (ii) Bablu @ Poltu Roy (32), S/o- Lt. Nirmal Roy of Surja Sen Colony, Block-E, PS- NJP, Dist- Jalpaiguri, (iii) Sanjay Roy @ Laden (22), S/o- Montu Roy of Shanti Para, PS-NJP, Dist- Jalpaiguri and (iv) Raj Chowdhury (22), S/o- Subal Chowdhury of Maharaja Colony, Near Bishal Mega Mart, W/No. 4, PS- Siliguri, Dist- Darjeeling and others and arrange for its investigation.
