On 05.12.2023 at about 04.05 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the commercial building of Debadrita Dutta Joardar (Ghosh) and inspected service installation, metering installation of Consumer ID 412053941 in the name of Lt.
