In producing herewith the 04(Four) accused persons namely 1. Md. Appu (M/26years) S/O- Lt. Md. Mustakim of Ashrafnagar, near masjid, Ward No-40, P.O-Haiderpara, P.S- Bhaktinagar, Dist-Jalpaiguri, 2. Kamal Thapa (M/27years) S/O- Gopal Thapa of Kholachand Fapri, near Bhanu Bhakta more, P.O-Salugara, PS-Bhaktinagar, Dist-Jalpaiguri 3. Gafur Md. (M/28years) S/O- Chaman Ali of Baliadangi, P.O-Digabana, P.S-Chopra, Dist- Uttar Dinajpur A/P- Gandhinagar, ward no-43, P.O-Sevoke road, P.S-Bhaktinagar, Dist-Jalpaiguri 4. I, PSI Chiranjit Saha, s/o-Madhab Saha of Bhaktinagar PS/SPC would like to lodge this written complaint against the above noted persons and 4/5 others persons to the effect that today i.e. on 04/12/23 at about 00.05 hours when I was performing PC night mobile van duty, at that time received a secret source information that a group of 08/09 persons had assembled at Salugara BSF road, near Pipeline under Bhaktinagar PS/SPC with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to I/C Bhaktinagar PS over telephone and as per telephonic instruction, myself along with other officers and force- SI Rantu Haldar, SI Mrinal Basunia, ASI Dipak Karmakar, C-374 Debraj Biswas, C-912 Nakul Chandra Singha headed towards Salugara BSF road, near Pipeline under Bhaktinagar PS/SPC to verify the veracity of the information and to work upon it. On way to the P.O I called one disinterest independent witness namely Ranjan Roy (34 years) s/o- Lt. Birendranath Roy of Vivekananda Nagar, Ward no-42, P.O.-Salugara, PS-Bhaktinagar, Dist-Jalpaiguri (Mob. No.9800463968) whom we disclosed our motto and identity and asked him to accompany us if any search and seizure is necessary for the purpose. We reached near the spot as directed by the source and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement and found a group of 08/09 persons sitting there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 04(Four) above referred accused persons. On interrogation the 04(Four) persons disclosed their identity as noted above and confessed that they along with 4/5 other persons had assembled there with a view to commit dacoity after making full preparation in the house Salugara of adjacent areas. Thereafter all the

apprehended persons were searched in presence of the witnesses and the following articles were recovered from their possesseion-

1. One iron made knife measuring about 18 inch in length recovered from the possession of accused Md. Appu (M/26years)

2. One iron rod measuring about 22 inch length recovered from the possession of accused

Kamal Thapa (M/27 years)

3. One iron rod measuring about 20 inch in length recovered from the possession of accused Gafur Md. (M/28years)

4. One iron rod measuring about 25 inch in length recovered from the possession of

accused Sonai Das (M/21years)

All the articles were seized in between 01.25 hrs to 02.10 hrs issuing a proper seizure list duly signed by the witnesses and the accused persons. Then, I arrested the above noted apprehended accused persons u/s-41 Cr.P.C after issuing memos of arrest,

as they had assembled for committing heinous crime in Salugara adjacent areas.

Under the above circumstances, I pray before you that a specific case may kindly be started against the 04(Four) persons arrested namely 1. Md. Appu (M/26years) S/O-Lt. Md. Mustakim of Ashrafnagar, near masjid, Ward No-40, P.O-Haiderpara, P.S-Bhaktinagar, Dist-Jalpaiguri, 2. Kamal Thapa (M/27years) S/O- Gopal Thapa of Kholachand Fapri, near Bhanu Bhakta more, P.O-Salugara, PS-Bhaktinagar, Dist-Jalpaiguri 3. Gafur Md. (M/28years) S/O- Chaman Ali of Baliadangi, P.O-Digabana, P.S-Chopra, Dist- Uttar Dinajpur A/P- Gandhinagar, ward no-43, P.O-Sevoke road, P.S-Bhaktinagar, Dist-Jalpaiguri 4. Sonai Das (M/21years) S/O- Anil Das of Baikunthapally, Ward No-43, P.O- Sevoke road, P.S- Bhaktinagar, Dist-Jalpaiguri (Not verified) and 4/5 other persons for assembling with deadly weapons with a view to committing dacoity.
