I Neha Ray Resident of Uttar Mallaguri, Champasari Anchal, ward no 46, Siliguri, Dist- Darjeeling would like to lodge a complaint against my husband Tanoj Ray who is currently residing at upper bagdogara jyoti nagar, that we have been legally married since 14th December 2009 after one year of marriage he started physically torture upon me for years but on 17/05/23 was enough for a normal person could ever take he was heavily drunk and made me forcibly to drink after some time he started fighting with me and started physically abusing me and my child and even called me and my daughter Randi, he brutally and continuously hit me that day with fist and blows and grabed me by neck ,and even hit me with his leg on my chest and has even hit me with chair I barely escaped and locked myself and my daughter in the room in the early morning I went to hospital with the help of my brother where I got to know that my rib was fractured I came home with the permission of the doctor as i had to take care of my minor daughter aged about 7 years and on that same day after I came from hospital he forced me to wear saree and brutally raped me, and again on next day he started abusing me my daughter this continued and on 25/05/23 at around 1.00 A.M he dragged me to the top floor of the building which has no boundary and was about to throw me but the tenant's in the house came for rescue and i survived or else i would have died that day he has even threatened me and tenant with dire consequences if i report it to anyone, I also came to know that he has an extra martial affair with a girl, that I having enough could not report it earlier as was afraid that he would hurt me and my daughter but now i cannot take it an more .

Therefore I kindly request you to take the necessary legal action against my husband as early as possible i have to live in fear he is still threatening me and I am afraid if he again comes to my house and again starts to torture and brutally assaults me .
