

In producing herewith three (03) arrested accused persons namely (i) Suraj Chettri (23) S/O Sosti Chettri of Ratanlal Busty ward No. 01, PO+PS-Pradhannagar Dist-Darjeeling (ii) Md. Samim (35) S/O Ayub Shek of Paribahan Nagar, PO+PS-Matigara, Dist-Darjeeling and (iii) Rintu Das @ Pocha (25) S/O Lt. Anukul Das of Lokhi Colony, Ward no.44, P.S. Bhaktinagar, Dist. jalpaiguri and (arrested u/s- 41 Cr.P.C) along with following seized articles viz:

(1) One iron made rod measuring 15 inch (approx) and one torchlight seized from the possession of Suraj Chettri which he was holding in his right and left hand.

(2) One iron made 'Kukri' measuring 13 inch (approx) including wooden butt seized from the possession of Md. Samim which was kept in his right hand,

(3) One iron made 'Knife' measuring 10 inch (approx) including plastic butt seized from the possession of Rintu Das @ Pocha which was kept on left and.

I, SI Sailesh Subba of Matigara PS. Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused persons and others to the effect that today on 08/12/2023 at 00:35 hrs received a source information that 10 to 12 youths had assembled at Nischintapur T.E, near Techno India School under Matigara PS with a view to commit docaity in a house at Himachal Bihar under Matigara PS area.

Subsequently, after sharing the information with Officer In charge and as per his direction, I along with other officer and forces of Matigara PS, SPC, left for above noted place to work out the information.

At about 01:00 hrs after reaching near Nischintapur T.E, I met my source and being pointed by the source we started walking towards the dense bushes near Techno India School and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot.

Seeing the Police team approaching towards them they tried to flee away, but on hot chase we managed to apprehend and detain the above noted three (03) accused persons along with seized articles as mentioned above. However, the other persons managed to fled away from the spot taking the advantage of darkness. On interrogation all the accused persons disclosed their identity as noted above and they admitted that they had assembled there and was making preparation to commit docaity in a house at Himachal Bihar.

Their presence at the suspicious place at small hours and from their statements it is evident that the detained accused persons along with their co- accused persons were assembled there to commit docaity at the house at Himachal Bihar under Matigara PS.

I thereafter, seized the above noted deadly weapons under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was made in between 01:25 hrs witnesses duly acknowledged by the accused persons. The whole seizure was made in between 01:25 hrs witnesses duly acknowledged by the accused persons u/s 41 Cr.P.C under proper memo to 01:55 hrs. Thereafter, I arrested the above detained accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. In course of interrogation, it could be revealed from the arrested accused persons that they along with their fellow associates were gathered at Nischintpur T.E for making preparation to commit docaity in a house at Himachal Bihar.

I therefore pray before you that a specific case may kindly be initiated under proper section of law against the above noted accused persons namely (i) Suraj Chettri (23) S/O Sosti Chettri of Ratanlal Busty ward No. 01, PO+PS-Pradhannagar Dist-Darjeeling (ii) Md. Samim (35) S/O Ayub Shek of Paribahan Nagar, PO+PS-Matigara, Dist-Darjeeling and (iii) Rintu Das @ Pocha (25) S/O Lt. Anukul Das of Lokhi Colony, Ward no.44, P.S. Bhaktinagar, Dist. Jalpaiguri and others and arrange for its investigation.
