734001, beg to state that I am an
Unmarried girl aged 20 years resides
along with my family at the above-
mentioned address.

Yesterday, i.e., on dated 07/12/2023
at around 9 pm in the night.

when all my family members i.e.,
my mother, Father and brother
Went to Salbari for some work,
Suddenly, 1) Sarita Devi Saw, w/o - ASHOKE

Saw, her daughter 2) Anjali Saw, D/o, -
Ashoke saw, and her son 3) Sanjay Saw,
S/o. - Ashoke Saw, all residents of Tikiya Para,
Matangini colony NO. - 2, Ward NO. - 28, P.O
& P.S - Siliguri, Dist. - Darjeeling, West
Bengal - 734001 trespassed into our
house and forcefully barged into my
room and started verbally abusing me
with filthy languages and physically assa-
ulted me with fist and blows. They also
tore my kurti which I was wearing and
snatched my nose - ring. Upon shouting
for help, Sarita Devi saw started physic-
ally assaulting me with a saw, Sanjay
Saw hit me with a iron pipe which he
brought with himself and Anjali Saw
bite me with her tooth in my thigh and
knees and dragged me holding my hair
and brought me in the road with my
torn clothes. I however managed myself
to escape from them and got inside my
room and locked myself and called
my Parents for help. Soon after

getting the information about the incident, my mother, Father and brother reached home and immediately took me to the Siliguri District Hospital for treatment and first-aid. After becoming helpless, when I returned my house soon thereafter at around 12:30 am in the night, against the above-named assailants, i.e. Sarita Devi Saw, Anjali Saw and Sanjay Saw come to my house and threatened me with criminal intimidation that I shall face dire consequences, if I again go to police station or any authority to lodge any complaint against them.

Due to the above-mentioned incident, I am in tremendous pain and shock and Trauma and in fear of my and my family members' life.

Therefore Sir in the above circumstances, I therefore politely request you to kindly take Penal and legal action against the above-named

assailants, make a strong case against them. Produce them before the appropriate forum and protect us from them.
