## **Subject: First Information Report.**

Respected Sir,

I, **SMT TUMPA SAHA(KUNDU)**, Wife of Sri Mantu Saha and Daughter of Sri Bhabatosh Kundu, presently residing at Bhola Chouhan Road, Anchal Office, Ward No. 40 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, beg to inform you as follows:-

- 1. That on 25-11-2007 as per Hindu rights and custom I got married with one Sri Mantu Saha, Son of Sri Narayan Chandra Saha, Resident of Anandamayee Kalibari Road, Haider Para, Ward No. 39 of S.M.C, P.O. Haiderpara, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin 734006 and it is right place to mention here that the marriage was arranged one as per affirmation held between my said husband as well as my family end. After marriage both of us started to live together as husband and wife at my above referred matrimonial residence.
- That in marriage, my parents as per demands of my said husband's family end, gave 7 Bori Gold ornaments, Rs. 40,000/- cash, furnitures viz. Wooden Bed, Almirah, Dressing Table etc., uncountable expensive wearing apparels for both of mine and my said husband, Pital as well as Kasa dish, glass items etc.
- 3. That since the inception of marriage, my husband's behaviour towards me was too rough and it is right place to mention here that my father-in-law namely Narayan Chandra Saha as well as Sister-in-law namely Munmun Saha always subjected me as a maid at my matrimonial house which resulted in immense mental agony to me.
- 4. That out of said wedlock within a span of year i.e. on August, 2008, I gave birth to a baby boy namely Surya Saha (Now aged about 15 years studying at Class 9) and it is trite to be mentioned here that during my delivery, due to malnutrition during my pregnancy period which resulted in serious weakness out of negligence on my in-laws family end, out of neurological attack I went on coma for 25 days at Mitra's Clinic, Siliguri and at the relevant moment my parents took every care and necessary requirements for my treatment and after recovering from such critical status and on being discharged from

Nursing Home, my above referred in-laws including my husband compelled me to stay at my paternal house and in the very event, my husband took the above child with him and later on during the upbringing of my son, never allowed the child to get much time spending concerns with his mother i.e. me.

- 5. That being recovered under the very paternal care and protection, after a lapse of 3 months i.e. on the middle of November, 2008, I arrived at my matrimonial place and started my conjugal life with my husband and also took every possible care of the child, during that time also without considering my physical health, my in-laws including my husband put continuous pressure on me to do household works and never gave any sort of basic maintenance needs including medicine expenses of mine for which my health was deteriorating both in mental and physical manner but I always tried my best to satisfy/adjust with my husband and other in-laws.
- 6. That out of extreme deterioration of health, I called my parents who took me at my paternal residence and used to take care of mine and again on being recovered I again came back to my matrimonial house and resume the conjugal life.
- 7. That my husband is having reputed business in the field of building material supply contracting concern having numerous number of heavy supply vehicles under his ownership and having net Rs. 2,50,000/- (Rupees Two Lac Fifty Thousand) only per month income out of the said business concern having luxurious life style.
- 8. That my husband is living with a lady namely Nivedita Chakraborty within the vicinity of my matrimonial residence area and used to avoid/neglect the conjugal relationship with me and my Father-in-law as well as other in-laws used to torture upon me continuously and out of such pressure I who in her past time undergone into coma and still under treatment used to take medicines faced too many disturbance with regard to my health. It is right place to mention here that in my matrimonial home no one from my in-laws family took any care of mine with respect to my medicine taking and/or bothered to know about the medicine timing of mine for reason/s best known to them.
- 9. That lastly on 05-03-2023 on the event of Holi festival my husband forcibly took me at the paternal house and left me with a plea that he would take me back few days later and I along with my parents with a hope that he would come soon did not opposed on his said proposal.

- 10. That after lapse of one and half months on May, 2023 when I along with my parents asked my husband over phone to take me back, he just denied to take me back on plea that he had already married with the above Nivedita Chakraborty and he would not resume the conjugal relationship with me in any manner.
- 11. That I being an unemployed housewife having medical issues under the dependency of old aged parents who had no source of income, finding no other alternatives come before you to get justice in this critical moment of life.

So, it is, therefore prayed to take appropriate legal action against my above husband namely 1) Mantu Saha, 2) father-in-law namely Narayan Chandra Saha, 3) 3) Munmun Saha (sister-in-law), 4) Nivedita Chakraborty who are under conspiring heads had done injustice towards me at the earliest instance for proper administration of Justice.
