In producing herewith 01 (one) arrested accused person named Suraj Kumar Chaudhary (24 yrs) S/O Amit Chaudhary of Vill- Auliabad, PO- Thandapur, PS- Bihpur, Dist. Bhagalpur, Bihar under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

(i) One blue colour suitcase containing 20 (twenty) bottles of "MAGIC MOMENTS, GREEN APPLE FLAVOURE VODKA" containing 375 Ml in each bottle i.e. total (375 x 20)= 7.5 liters, Blended and bottled by Sikkim distillers Ltd, Rangpo, Sikkim and marked as Exhibit "A" out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "A1".

I, SI Goutam Mallik S/O Late Nikhil Ranjan Mallik of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted arrested accused person named Suraj Kumar Chaudhary (24 yrs) S/O Amit Chaudhary of Vill- Auliabad, PO- Thandapur, PS- Bihpur, Dist. Bhagalpur, Bihar to the effect that today on 15.12.23 at 19.15 hrs I received a specific source information that one person with a blue colour suitcase in his hand containing illegal liquor is waiting at Siliguri Junction near Raj Bus Stand for a Bihar bound bus. Accordingly, the matter was diarized in General Diary vide Pradhan Nagar PS- GDE No 794 dated 15.12.23 and informed the fact to the I/C, Pradhan Nagar PS and as per his kind order and direction myself along with SI Youel Lepcha, ASI Monoj Kr Roy, ASI Biplab Kr Das C/473 all of Pradhan Nagar PS left for Siliguri Junction near Raj Bus Stand to verify the Amrita Sarkar veracity of the information in hand. After arrival at Siliguri Junction near Raj Bus Stand and as identified by the source we managed to apprehended one person with a blue colour suitcase in his possession. On being asked he disclosed his identity as noted above and also disclosed that he collect illegal liquor from one of his supplier of Sikkim with a view to sale the same in Bihar for his wrongful gain. On search the suitcase found in his possession the above noted illicit liquor recovered from his possession. On demand he failed to produce any valid license/papers in respect of the above noted illicit liquor recovered from his possession. On further interrogation he stated that he is involved in selling and possessing of illegal liquor without any valid license since long for his illegal gain. Accordingly, I seized and labeled the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and subsequently, arrested the above mentioned accused person named Suraj Kumar Chaudhary (24 yrs) S/O Amit Chaudhary of Vill- Auliabad, PO- Thandapur, PS- Bihpur, Dist. Bhagalpur, Bihar after observing all sorts of formalities at the spot. The whole process of search, seizure and label has been made in between 19.45 hrs. to 20.55 hrs.

Under the above noted fact and circumstances I, pray before your good self that specific case may kindly be initiated against the accused person namely Suraj Kumar Chaudhary (24 yrs) S/O Amit Chaudhary of Vill- Auliabad, PO- Thandapur, PS- Bihpur, Dist. Bhagalpur, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
