Dear Sir,

I Smt. Rani Prasad alias Rani Mahato (7908492872), Wife of Sri Deepak Prasad, Daughter of Late Ram Bilash Mahato, resident of Praksh Nagar, Limbu Basti, Police Station- Bhaktinagar, District-Jalpaiguri at present residing with my husband at Ektiyarshal, Khudirampally, Police Station- Bhaktinagar, District- Jalpaiguri would like to state that I got married to Sri Deepak Prasad (9832491668), Son of Late Sunil Prasad on 02.06.2013. Right from the beginning of the marriage I and my husband did not enjoy the marital happiness due to the greedy nature of my husband and my mother in law namely Smt. Manosa Debi, Wife of Late Sunil Prasad and Sister-in-Law Lachmi Prasad, Daughter of Late Sunil Prasad who were more interested in earning money through dowry demanded from my brother namely Sanjay Mahato. At the time of my marriage my brother being a small businessman dealing in a small business earning a basic meager income but inspite of that, he provided my husband and in laws with numerous articles including cash amount of Rs.30,000/-, gold ornaments, expensive household articles among some. The demand of my husband and in laws did not cease and they used to repeatedly torture me for not bringing enough dowry. From the inception of the marriage I was always ill treated and I did not have the respect and dignity of a wife. My husband always abused me with filty language and still continues to do the same without any reason and my mother and sisiter in law always supported him. However I stayed in my matrimonial house with an expectation that things would improve but nothing improved and the situation only detiorated. My husband namely Deepak Prasad started coming to house late at night everyday in an intoxicated state and when intervened by me and questioned by me as to where had you been, my husband used to turn violent and used hands on me and beat me with fists and blows. This instance of physical torture continued and I have been tolerating the same. On 19.11.2014, when I had no other alternative I informed my brother and he somehow resuced me from the brutal clutches of my husband and I was even rushed to Siliguri District Hospital for treatment. To that score, I even lodged a written complaint with Bhaktinagar Police Station and a specific case was started being Bhaktinagar P.S. Case No. Page - 1 - of 3

1573/2014 dated 19.11.2014 u/S. 498A, 506, 34 of the Indian Penal Code read with section 3 & 4 of Dowry Prohibition Act.

I further filed an application under section 12 of the Domestic Violence Act, 2005 and the said case was registered and numbered as Misc Petition No. 46/2015 before the Ld. Judicial Magistrate, 1st Court at Jalpaiguri and on 15.09.2016, the Ld. Court was pleasded to pass an order directing my husband to pay an amount of Rs.5,000/- per month as mainteanance and a sum of a Rs.2,000/-per month towards rent. It is pertinent to mention here that my Husband preferred an appeal but the said appeal was dismissed an the order dated 15.09.2016 was upheld. Subsequently as my husband did not comply with the order dated 15.09.2016 and accordingly, I was forced to institute execution proceeding being Misc. Execution Case No.-104/2018. However since huge arrears had incurred warrant of arrest was issued against him. However since my husband and in laws pressurized me to withdraw the case, I withdrew the Misc. Execution Case No. - 104/2018 solely on good faith with a hope that I should give an opportunity to my husband and in laws and in order to save my matrimonial life. Further my husband had given a written undertaking wherein he admitted his guilt with a promise to continue our marriage and give me all the repect that I deserve as a wife and sought apology and with the intervention of family members and well wishers on both the sides, I withdrew the case and decided to return back to my matrimonial house on 17.11.2023 but since the very date my husaband, my mother in law and sister in law again started brutally toruting me both physically and mentally. They stopped me from talking to my brother over telephone and I was somehow confied in a room in my matrimonial house and was not even given two square meals a day. I was completely starved and became physically weak. However today morning I somehow managed to muster the courage to leave my matrimonial house and somehow informed my brother but as my husband realized this he became furious and today i.e. 16.12.2023 at around 8:00 a.m., my husband suddenly grabbed me from behind while I was in my room and with full force put his hands on my mouth and also closed my nose with his fingers and tried to choke me with the only intention to kill me. I started to save myself from the clutches of my husband and ran away and therafter he grabbed a knife and stabbed me with a knife. My husband thereafter started abusing me with filthy words and more particularly said "AAJ TUJHE MAR DALUNGA". I tried to save myself I escaped from my husband. He thereafter pulled me and at that particular instance I got injured in my hands, neck and

thereafter assaulted me with fists and blows and I started bleeding from my hands. The mere intention of my husband was to kill me. My husband cut my hand and I started bleeding profusely, in the entire process my mother in law and sister in law held my hand while my husabnd attacked me with the knife. I received grievious injury. The residents of the neighborhood gathered there to save me as I screamed loudely and begged my husband to leave me and was immediately rushed to Siliguri District Hospital for emergency treatment.

My husband has never provided me anything apart from a square meal, he does not allow me to keep my mobile with me with a fear that I might inform my brother and relatives. He does not leave any chance to abuse me. I am in constant fear of threat of losing my life and there is every possibility that my husband might attack me once again and kill me.

I therefore request you to investigate the matter and book the aforesaid culprits Deepak Prasad, Manosa Debi and Lachmi Prasad in accordance with the appropriate provisions of law.
