- (i) That one **Jackson Dass** Director of Travishield Hospitality Services (opc) Private Limited having Corporate Identification No.U63030MH2023OPC397803 Registered Office Address 255, Jay Hind Co-oprative Housing Society, Khartan Road, Mahatma Phule Nagar, Thane-400601, Maharastra called a meeting in the Saluja Hotel, H.C. Road, Siliguri on 01.07.2023 alongwith his companion lady **Ekta** having Mobile No. **91367-62869** and induced me to take their Club and Vacation Membership and accordingly I have purchased Club and Vacation Membership vide Contract No/Membership No. THSS#1247 dated 01.07.2023 and paid an amount of Rs. 4,95,000/- through my Credit Card No. 4501720946711008 and Debit Card No. 5166401929002433 respectively on 01.07.2023. Copy of Bank Statement is enclosed herewith for your kind perusal.
- (ii) That thereafter they have provided me Premium Digital Voucher worth Rs.1,50,000/- in which they have invited me for a tour by their aforesaid company for the destination Goa, Mundra Mani, Manali, Darjeeling, Gangtok, Puri and Bangalore respectively.
- (iii) That after getting the gift youcher on 23.09.2023 I called on their Toll Free number and discussed with their executive giving my membership number to her and asked her to book my tour for Goa on 26.10.2023 but the said lady told me that she is unble to process my request for booking and asked me to mail regarding the same.

- That on 04.10.2023 I again called on Toll Free Number and told that I want to meet with your executive at your Kolkata Office but the lady who attended the call started to argue with me and transferred the call to one Mr. Rahul and he talked to me and provided their Mumbai Office Address and suggest me to mail for tour to Goa on 26.10.2023 and also informed me that their existing Kolkata Office mentioned the the Cotract Note has been closed and shifted to other place.
- That the aforesaid Gift Voucher provided to me was valid for Six Months and (v) required to be used within 31st December, 2023 so I made several reminders through mail for booking of my trip to Goa but in vain. Copy of mails enclosed herewith for your kind perusal.
- That the aforesaid person with their companion have cheated me for Rs. 4,95,000/- and made false and fabricated promises for tour on behalf of the company vide Agreement dated 01.07.2023 and also collected a sum of Rs.1,04,828/- on 06.11.2023 through auto debit from my ICICI Account No.192901001529 illegally without my knowledge. Copy of agreement and Bank Statement is enclosed herewith for your kind perusal.

As such, you are requested to take appropriate action against the aforesaid persons under the provision of law for cheating, fraud and criminal conspiracy of Rs.5,99,828/-(Rupees five lakhs ninety nine thousand eight hundred twenty eight) only with me for the ends of justice and oblige.
