Sir,

I, Mou Paul, resident of Bijoy Apartment, Rash Behari Sarani, Ward no 17, Hakingpara, Siliguri - 734001, have been married to Mr. Joyabratna Paul, s/o Subrata Paul, for the past 25 years.

He has been addicted to drugs for the past 12 years. However, he has taken steps by going to rehab with my mental and financial support. His own family had abandoned him, and we has been living with my mother and my children. and we have faced a lot of financial hardships due to the fact that he does not have any job or work. I have struggled to make ends meet and give my children a normal life as far as I have been able to.

The last couple of weeks have been especially difficult with him behaving mentally unstable. Today evening, things went too far and he verbally and physically abused me and my elderly

mother. Luckily, my elder son was there to save our lives and defended us. In the process, even he got injured when my husband threw the knife at him. He also pushed us and when the neighbours came to our self-defence, he injured himself and fled ~~when~~ when the police was about to arrive.

We have given preliminary statements verbally to the patrolling van that came to our house and hereby request you to treat this as a first incidence report/statement.

The person also came to my workplace today and created a scene and threatened me. I would like to request you to please treat this situation with utmost priority and would request you to provide us with security for the safety of our lives and our well-being, as he has verbally threatened us that he will murder us. He has even been carrying a butcher's knife around with him.
