SUB: COMPLAINT AGAINST PALASH CHOWDHURY AND MANTOSH DHAR FOR INJURING ME AND ATTEMPTING TO KILL ME.

Sir.

I am writing to bring to your notice that I Sri. Sunil Debnath, S/o Late. Jagadish Debnath, aged about 80 years, currently residing on the 4th Floor at Jagadish Apartment, College para, Ward No. 17 of S.M.C, Siliguri, West Bengal, Dist: Darjeeling, P.O and P.S; Siliguri with my daughter Smt. Suchitra Nath and granddaughter Miss. Shreya Nath.

Over the last few months my neighbors namely Palash Chowdhury along with his wife Mousumi Chowdhury and Mantash Dhar who reside in our apartment on the 2nd Floor have on purpose started disturbing us and threatening us and have been abusing us. I am a senior citizen aged about 80 years and I live with two girls. We've have been under constant threat from the above-named persons.

The above-named two persons over the past week has been increasingly creating nuisance and passing remarks at my daughter and granddaughter. Palash Chowdhury and Mantash Dhar threatened me that they will send their men to rape my daughter and granddaughter, considering they live alone in the flat.

Yesterday on the 17th December at around 9Pm to 9.30Pm when my daughter was using the shared Lift of our apartment these two persons intentionally shut down the lift and my daughter namely Smt. Suchitra Nath was trapped inside between the 2nd Floor and 3rd floor. I was downstairs and hearing my daughter scream I tried to rush through the stairs to save my daughter and then Mantash Dhar held me from behind and Palash Chowdhury started

beating me with fist and blows. I being 80 years old could only resist much and then Palash Chowdhury took out a sharp object from his pocket and tried to hit me on my head with intention to kill me by saying "Ajke merci felbo" but somehow I saved myself and the sharp object hit me on my hand and it started to bleed. If the sharp metal object would hit me on my head I would have been dead. They both continued to assault me and Palash Chowdhury again tried to kill me using the sharp object but somehow I was able to release myself and I rushed to help my daughter.

With all the screaming and noise all the other people around came out and with their assistance I again restarted the lift connection to save my daughter. She was almost senseless. Thereafter I was taken to the hospital for medical

Kindly take note of the following and help me and my family from these persons who have been trying to kill us. They will again find another opportunity to kill me and do harm to my daughter and granddaughter.
