In producing herewith the 03 (three) arrested accused persons namely 1) Rintu Kumar Prasad (26), S/o- Bijay Prasad of Ramdatali, PS- Sahapur, Dist- Bhojpur, Bihar, 2) Raju Yadav (35), S/o- Choton Yadav of Chitkuri Chakia, PS- Mafasil, Dist- Bhojpur, Bihar and 3) Inderdev Prasad (75), S/o- Lt. Shiv Prasad of Parasia, PS- Barahapur, Dist- Buxer, Bihar along with the following seized articles under proper seizure list :-

I, SI Samik Paul, S/o- Anil Ch. Paul of New Jalpaiguri Police station, SPC do hereby lodge this written complaint against above noted 03 (three) arrested accused persons to the effect that today on 18.12.2023 at about 14.45 hrs, I received a specific source input that one vehicle having registration no. UP 60 L/ 4328 is coming from Assam side with huge consignment of suspected to be Ganja for it's clandestine disposal. The matter was diarized vide NJP PS PS GDE No. 1070, Dt. 18.12.23 and informed the matter to you and expressed the entire information. As per your kind direction myself along with other officers and force named ASI Khagen Barman, ASI Dhruva Mishra, C/453 Uttam Dey, C/152 Abdul Kayum Mia, VP/13 Jamirul Islam all of NJP PS, SPC being headed by me left for Ramkrishna Dhaba @ Pradip Hotel under New Jalpaiguri PS, Dist- Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 1071, Dated- 18.12.2023 and M.C.C. No. 2028/23, Dated- 18.12.2023. I also informed the Videographer namely Tapan Mandal, S/o- Tusto Mandal of Bhola More, PS- NJP, Dist- Jalpaiguri to be present at Gora More, under New Jalpaiguri PS, Dist- Jalpaiguri to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 15.15 hrs we arrived at Parking place of Ramkrishna Dhaba under New Jalpaiguri PS, Dist- Jalpaiguri. After reaching at the spot, I called two independent witnesses namely (i) Shri Sailesh Khati (35), S/o- Nur Bahadur Khati of Pakkim Bazar, PS- Pakkim, Dist- East Sikkim, Sikkim A/P Ramkrishna Dhaba, PS- NJP, Dist- Jalpaiguri and (ii) Shri Surojit Sarkar (30), S/o- Gautam Sarkar of Ranidanga Anchal Office, Near SSB Camp, PS- Bagdogra, Dist- Darjeeling, A/P- Ramkrishna Dhaba, PS- NJP, Dist- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as independent witnesses under relevant provision of law. After arrival at the spot we are waiting for the target. Mean while I sent notice to the Special Executive Magistrate named Shri Kartik Dey, WBPS, ACP, Traffic (H.Q.), SPC through special messenger with a
