REQUEST TO LODGE FIR AGAINST THEFT OF GOVT PROPERTY

1. On 17 Dec 2023 at around 1530hrs, I was going back to my unit i.e 16 FAD where I am posted since 06 Oct 2022. Near K' Zone family married accommodation (near HRD) I noticed few ladies are carrying some scrap items and they were loading it into an auto rikshaw Regd No WB 73E 3602. Upon suspicion, I questioned the ladies about the items which they were carrying and they failed to give any satisfactory reply.
2. I checked the items and found out that these items are govt property and most of the items were of my unit i.e 16 FAD which include metals, batteries and plastic items. On further questioning and confrontation, the Qadeer and the rikshaw were ran away from the location, leaving behind the sacks full of stolen items.
