Sub: F.I.R against Sri Bani Barman @ Bittu, Son of Sri Gopal Barman resident of New Colony, Matigara, Post Office & Police Station-Matigara, District-Darjeeling, Pin-734010 and Smt Rinki Das, Wife of Sri Pintu Das, residing Opposite Margaret School, P.O & P.S-Pradhannagar, District-Darjeeling, Pin-734003.

I Smt Munmun Barman (Ghosh), Wife of Sri Bani Barman @ Bittu resident of New Colony, Post Office & Police Station-Matigara, District-Darjeeling, Pin-734010 and presently residing at my paternal house at Tumbajote, Near West Point School, Post Office & Police Station-Matigara, District-Darjeeling, Pin-734010 would like to inform you that I got married to Sri Bani Barman @ Bittu on 23rd February, 2013 as per Hindu rites and customs at my residence in presence of friends, family members, kith, kin of both the parties, the said marriage was out of love and affair.

After the marriage on 25th February 2013 the boubhat ceremony was held at my matrimonial house at New Colony, Matigara, I and my husband started to live together as husband and wife at my matrimonial house at New Colony, Matigara.

Since marriage I was subjected to both mental and physical torture by my husband, on slightest differences of opinion my husband used to beat me inhumanly with his belt, I silently tolerated the torture in order to survive our marital tie, my husband also pressurized me and my family for giving a dowry of Rs 5,00,000/- (Rupees Five Lacs) only to him so that he can purchase a Maruti Suzuki Swift for his personal use.

Among all negativities and ill behaviour I on September 2016 conceived and my in laws were very happy but my husband was very sad and expressed his dissatisfaction through his acts and activities, he never accompanied me to the doctor's chamber or to the pathology clinic.

On 10.06.2017 I gave birth to a female child at Roy's Nursing Home, Tilak Road, Siliguri, all my family members and my in laws were very happy but my husband taunted me saying "ami jantam tor dara chele bacha hobena", after four days of delivery on 22.06.2017 my child expired due to early onset neonatal sepsis with refractory shock at North Bengal Medical College and Hospital.

My husband mortgaged my gold chain and gold locket at Muthoot Finance, Sevoke Road Branch and took a loan vide loan No. 2545-MWS-2397, he also mortgaged my gold top and chik to Amar Bhowmick, S/o Sri Ramendra Chandra Bhowmick who is a money lender and took a loan of Rs 18,000/- (Rupees Eighteen thousand) only, moreover he pressurized me to take a joint loan and threatened me saying that if I don't sign in the loan agreement then he will kill me.

Subsequently I was forced by my husband to take many joint loans at Bandhan Bank amounting to a total sum of Rs 2,00,000/- (Rupees Two Lakhs) only through my savings account being No.50150020382949.

My husband further forced me to take a joint loan through L & T finance amounting to a sum of Rs 25,340/- (Rupees Twenty Five Thousand Three Hundred Forty) vide loan account id being L08195778099.

My husband was into an illicit relation with Mousumi Ghosh, my husband assaulted me several times and my husband even brutally assaulted me and thereafter I was forced to lodge a F.I.R against my husband before the Officer In Charge, Matigara PS informing the above facts.

Later my husband told me that he will never torture me anymore and as a result of which I patched up with him and started living together.

Thereafter I conceived again and on 11.04.2022 I gave birth to a female child out of our lawful wedlock at Akash Nursing Home, but my husband's torture increased with time.

My husband has again entered into an illicit relationship with another lady namely and Smt Rinki Das, Wife of Sri Pintu Das, residing Opposite Margaret School, P.O & P.S- Pradhannagar, District-Darjeeling, Pin-734003 who instigates my husband to torture me and my daughter and is involved in the crimes committed by my husband.

Every night my husband comes in an intoxicated condition under the influence of alcohol and beats me and my minor daughter and tells me to give divorce on mutual consent.

My husband has stopped providing the necessary expenses of my daughter and myself.

My husband many times caused my miscarriage against my will by forcefully feeding me abortive pills.

On 10.12.2023 at about 2:30 P.M my husband started assaulting me with fists and blows, he did punch me in my left ear as a result of which I am still not being able to hear on my left ear.

My husband tried to kill my daughter by strangulating her but somehow I could prevent my husband from killing my daughter. I could not move due to pain thus one day after on 11.12.23 I was treated at Matigara Block Primary Health centre. I could not lodge the written complain earlier as I was in very much bodily and mental pain.

I therefore request your good office to look into the matter and take necessary action against my husband and Smt Rinki Das as per the law of the land.

Please treat this as very urgent and do the needful
