I, Ranadip Mazumder, Son of Lt. Kalipada Mazumder, A.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against Asgari Khatoon, (Ph- 7384411987), Resident of Himali Shahid Nagar, Ward No-43,

Siliguri, Dist-Jalpaiguri, P.S Bhaktinagar, West Bengal.

While on a routine inspection on the site having consumer id 401665311, meter no B4228256, having power connection of WBSEDCL in the name of Fatma Khatoon (Ph- 9749063899) in the address being Himali Shahid Nagar, Ward No-43, Siliguri, Dist- Jalpaiguri, P.S Bhaktinagar, West Bengal being used by Asgari Khatoon, I, Ranadip Mazumder, Assistant Engineer & Station Manager, Power House CCC along with Sri Jyotiska Sengupta, Sr. O.E., Power House CCC, WBSEDCL and Sri Sanjay Prasad, Sr. O.E, Power House CCC, WBSEDCL and other technical staffs observed that the energy was being used unauthorizedly by reconnecting the Deemed Disconnected meter (Bentec make, SI. No. B4228256, property of WBSEDCL).

We entered the premises at 12:50 hrs on 22.12.2023 after handing over Notice to Babu Alam present during inspection. Then it was observed that the power was being used in an unauthorized manner by reconnecting the Deemed Disconnected meter. Therefore committing a crime for theft of power as per section 135 (1) (a) & 138 (1) (b) of The Electricity Act 2003 amended on 2007 of India. A maximum Demand of 0.49 KVA was found recorded in the energy meter as on 20.11.2023. Accordingly the connection was disconnected and the energy meter and service cable were seized and labelled. A copy of both inspection report and Seizure list (1. Bentec make, 1 Phase, 240 Volts, 5-30 amps, SI No B4228256 with Last Reading-8755 KWH, property of WBSEDCL, 2. Service Cable of Black Color,4 Sq mm, Single Core Aluminium wire of 35 meters approx, 3. Topson make MCB, SI No. BB40320C - 32 amps) were handed over to Babu Alam present during inspection. We exited the premises on 13:40hrs.

Thus you are requested to kindly initiate an investigation against Asgari Khatoon under Section 135 (1) (a) & 138 (1) (b) of the

Electricity Act 2003 amended on 2007 of India.
