I Smt. Babita Saha (Sarkar), W/o. Sri Kamal Sarkar, and Daughter of Sri Sushanta Saha, Resident of Ambari, Post Office More, P.O Kamarbhita, P.S. New Jalpaiguri, Dist. Jalpaiguri, would like to inform you that, I am the legally married wife of Sri Kamal Sarkar, S/o. Bimal Sarkar Resident of Ambari, Saheb Para, P.O Kamarbhita, P.S. New Jalpaiguri, Dist. Jalpaiguri on 17.01.2023 according to Hindu Rites & Customs in my paternal house.

I would like to further inform you that, I and said Kamal maintained a long relationship and there was a love and affairs and our both parents accepted our relation and thereafter our both family members arranged for our marriage. At the time of my marriage my parents had given a Dressing Table, Sofa Set, Refrigerator, LED Television, Godrej Almirah, Steel Alna, Bed Set (2 Blankets, Mattress, Pillow with cover, Bed sheet, Masari), water purifier, Brass utensils (Kasar Thala 2 pcs, 2 glasses, 2 bowls, one Kalsi, One Ghati, Puspa Patra, Balti), 3 pcs Trolley Bag, Watches, alongwith gold ornaments (two gold Chick, One gold Necklace, One pair gold Jhumka, 5 pair Ear Rings, 7 pcs Nosepin, One Pair Sankha with gold, One Pair Pola with Gold, One Gold male chain, One Mangalsutra, two pcs female finger ring, one pcs male finger ring) and other necessary articles as per the demand and pressure of my husband and his mother and said articles are taken by my husband and his family members at the time of leaving my paternal house.

I would like to further inform you that, on 18.01.2023 my husband brought me in his house and on the same day at night my mother in law Smt. Malati Sarkar and wife of the brother of my husband namely Khuku Sarkar @ Khusi have started to make comments in regard to the quality of articles which my parents have given at the time of my marriage and surprisingly they both have also stated that those articles are required to be shifted to the room of elder brother of my husband. And being a newly weeded wife I did not pass any comments. On the next day i.e. the day of reception my mother in law and sister in law namely Smt. Monika Sarkar and the wife of brother of my husband have started to abusive language in favour of me and my family members as why my family did not arrange the pranami dresses for the cousin sisters of my husband whereas my parents have arranged 14 numbers of Sharees and 5 numbers of Shirts. My mother in law, sister in law, brother in law Nirmal Sarkar and his wife kicked on the articles like sofa, almirah and fridge and they have also thrown out the said articles and seeing the said unnatural behaviour from my in laws I started to crying in my husband's room and they have also using slung languages upon me and my family members which cannot uttered in a civilized country. After some time my husband came to my room and he also threatened me with dire consequence and he told me not to create any scene as the day was reception and so many guests will come.

I would like to further inform you that, after three days from reception my younger uncle and my maternal uncle came to my in laws house to receive me and my husband for the rituals of 'astamangla' and after elapsing of two days I alongwith my husband came back to my maternal house and we have started our conjugal life but after elapsing of two to three days I found some unnatural behaviour of my husband. Most of the time he used to spent time with his *Boudi* (wife of brother of my husband). And when I asked my husband, he used to slap me and his mother and boudi also used abusive and filthy languages.

I would like to further inform you that, each and every time my husband and his mother used to demand 2.5 lacs to purchase a bullet and they have also told me that I belongs from a beggar family and for that my father unable to provide them cash in our marriage and if my mother in law used to arrange another place for marriage of her son she will get handsome dowry as because my husband is a contractor of interior decorators and he is earning morethan 1 lakhs per month. On one occasion my husband started to quarrel with me and kicked me on my belly without any reasonable cause and he also told me that he will send me to my parents house and thereafter I voluntarily left my maternal place and came to my parents house and on the same day my husband came to parents house and accept his guilt and I again started to reside with him.

I would like to further inform you that, on 16.05.2023 I found my husband with his boudi in a compromising situation and after seeing the said unnatural relation I tried to raise objection but my husband, mother in law and the wife of brother of my husband used to beat me and using so many abusive languages and for that I closed my room and I started to crying alone. Suddenly my mother in law informed my parents and when my parents came to my in laws house my mother in law, brother in law, his wife and my sister in law used to so many stories which has no nexus with the actual facts and truth and even they have tried to cover up with the high voice and finding no other alternative my family members bring me to my own house and since then I have live in my parent's house.

I would like to further inform you that, on 17.05.2023 the brother of my husband namely Nirmal Sarkar called my mother's mobile phone and he also threatened my mother, he told me and my mother that he will be tied to me and my mother with a tree and beaten and he will break our legs. On 24.05.2023 my husband came to my parent's house and he again accepts his guilt and started to live with me in my paternal house.

After residing almost 12 days he again leave my paternal place without informing anyone. Thereafter again he came to my house after elapsing of 5 to 6 days and told me that he arranged a residential accommodation on rental basis at C/o. Suman Paul, Medical More, Pelku Jote, Near Kadam Bagan, P.S Matigara, Dist. Darjeeling and for save our matrimonial tie I went to the said tenanted premises with said Kamal Sarkar.

I would like to further inform you that, after elapsing of some days my husband started to neglect me again as previous, most of the time he used to talk with his mobile phone and on one occasion I found he frequently talked with his boudi and even he stopped to pay any expenses for daily foods finding no other alternative I called my father and he used to provide me foods and other necessary items. On 19/12/2023 at midnight at about 2.30 a.m. my husband started to slap me and for his unnatural behaviour I wake up and I became very surprised and without any reason he kicked on my lower belly finding no other alternative I called my father and hearing the said news my parents came to my residential house at morning and rescue from the clutch of my husband and on 20.12.2023 I was treated at Siliguri Hospital and due to my bad health condition I was unable to lodge any complaint.

Under the above circumstances I would like to inform you that, kindly investigate the matter and take necessary and strong action against my husband Kamal Sarkar, his mother Smt. Malati Sarkar, sister Miss Monika Sarkar, brother Nirmal Sarkar and wife of his brother Smt. Khuku Sarkar @ Khusi for their illegal act and activities.
