SUB:- LODGING OF FIR

On dtd 23.12.23, on a specific source information regarding movement of 01 truck carrying cattle heads to Assam with the motive of smuggling to Bangladesh. On getting the information special joint operation has been planned by Sh Shailendra Singh, AC, Coy Comdr of 'D' Coy BOP Fulbari ex 176 BN BSF with Police. As per planning the party comprising 01 Officer, 05 SOs and 02 ORs (Including G rep) of BSF and police party of NJP PS, Pranav Kumar Singha along with 03 Ors laid a special ambush on NH 31 behind the general area of BOP Fulbari ex 176 Bn BSF. At around 240330 hrs party observed the movement of suspected truck bearing registration no PB03BD2879 which was coming from Fulbari bridge side on NH 31. At about 240335 hrs the truck was intercepted by the ambush party near Fulbari Toll Naka. The party asked the driver to produce necessary documents but no documents pertaining to truck and loaded buffalos were produced by the driver. The buffalos were badly stuffed inside the truck and many of them injured due to scramble and lack of space. On counting it was revealed that there were 40 buffalos inside the Accordingly 01 truck bearing No PB03BD2879 and 40 no's buffalos were seized by the party and 01 driver and 04 helpers also apprehended.
