Leela Bhutia resident of Darjeeling and sukhia pokhari (all senior citizen and tribal ladies) are the registered owners of the total area of land 7 bigha pertaining L.R plot no 14 and 16, mouza dhukuria, po salbari, dist Darjeeling under three different khatians purchased in the year 1988 and 1989 from the different persons and are in actual physical possession of the land and our names have duly been recorded in the Records of Rights maintained by the B.L. &L.R.O, Shivmandir, Matigara.

That, on 24th of decemebr 2023 at 12 noon we all wanted to demarcate our land and fence it by measuring with the help of a private Amin and other persons and had gone to our land at Dhukuria Mouza but all of a sudden one Bijay Kumar Sah, son of Late Ram KhilawanSah of Nandalal Path, Salbari, P.O. Salbari came at our land along with his goons and obstructed us from doing any work of measurement and boundary of our said land and abused us in a filthy language and also threatened us to kill if we do not leave our land immediately.
