I Smt. Soni Kumari (Mob: 8670028198) wife of Sri Sudhir Kumar, resident of Baghajatin Colony, Ward No. II of S.M.C., Near- Vivekananda Hindi Primary School, P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, would like to inform you the following facts:-

- 1. That on 30.05.2023 I purchased a piece or parcel of vacant land measuring 540 sq.ft. out of 1.5 katha situated at Mouza- Siliguri, J.L. No.88(110), Sheet No.02, Pargana- Baikunthapur, P.S. Pradhan Nagar, Dist. Darjeeling from Sri Mahadev Sandal son of Anand Sandal of Baghajatin Colony, Ward No. II of S.M.C., Near- Vivekananda Hindi Primary School, P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling by virtue of Deed of Transfer of Possession and I made a room under teen roof thereon and I have been residing there along with my husband and my minor son since I purchased the said land.
- 2. After that taking advantage of my neighbour and her family members namely (i) Smt. Rekha Devi wife of Sri Rishidev Thakur, (ii) Sri Rishidev Thakur, son of Tanuk Lal Thakur, (iii) Suraj Thakur son of Rishidev Thakur, (iv) Priyanshu Thakur son of Rishidev Thakur, (v) Sonam Kumari daughter of Rishidev Thakur all are residing at Baghajatin Colony, Ward No. II of S.M.C., Near- Vivekananda Hindi Primary School, P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, want to occupy my said land house illegally and unlawfully. But several times I requested them to maintain the peace each other. After that on that time my husband namely Sri Sudhir Kumar came to the incident and he tried to save me from her hands and then she also physically assaulted my husband.

That due to such assaulted upon me and my aforesaid husband and due to her such attempt to murder me in such cruel manners, I sustained severe injuries on my persons and I am medically treated at Siliguri District Hospital, Siliguri, Dist. Darjeeling on 24.12.2023 at about 6.30 P.M. and still I am under medical treatment.
- That due to serious injury caused due to such assaulted by her upon me and my aforesaid husband delay is caused for lodging this F.I.R. which may kindly be condoned.
