Sub- First Information Report.

Respected Sir, *s/o Sanat Prasad Rastogi*

I, Mohit Rastogi, am writing to report a distressing incident involving the assault of my mother, Indu Rastogi, and my sister, Salu Rastogi, who recently delivered a child, which transpired on the aforementioned date at Pradhan Nagar. This FIR is lodged to seek immediate intervention and justice regarding the incident. The purpose of this report is to seek immediate intervention and justice for the victims who are in mental agony and pain, deeply traumatized by the events.

Incident Details:

1. **Date and Time:** 08/01/2024, at approximately 2:30, within the vicinity of Pradhan Nagar. I've called on the 100 number but there was no reply from their side.

2. Victims:

- Indu Rastogi (my mother)
- Salu Rastogi (my sister)
- Aniket Rastogi (my brother)

3. Perpetrators :

Ajay Rastogi and Vijay Rastogi
Satye Dev Rastogi
Anita Rastogi
Mona Rastogi

4. Description of the Incident:

- Salu Rastogi, who was recovering from a C-section, suffered severe injuries during the assault, exacerbating her recovery process and causing significant distress.

- Indu Rastogi was subjected to forceful hair pulling, resulting in immense physical pain and deep mental trauma for both victims.
- The incident has left both victims in a state of severe mental agony and physical pain, causing immense trauma and distress

5. Immediate Actions Taken:

Upon witnessing the assault, I immediately called the emergency number 100, seeking urgent assistance. However, the police advised taking the victims to the hospital first and then reporting to the police station.

6. Subsequent Actions:

- In adherence to the advice received, I promptly took my unconscious and severely injured sister, Salu Rastogi, to Sister Nivedita Hospital for immediate medical attention and admission.
- Simultaneously, I directly took my mother, Indu Rastogi, to Siliguri District Hospital to ensure immediate medical attention and safeguard her well-being, as instructed.

7. Supporting Information:

- Medical reports detailing the injuries sustained by the victims. (Annexed with the application)
- Witness Pinky Rashtogi and Rohit Rashtogi are willing to testify regarding the incident.

I humbly request a thorough investigation to identify and apprehend the perpetrators responsible for this appalling act. I seek justice and immediate action to ensure the safety and well-being of my family members. I earnestly implore your prompt attention and action regarding this matter. I am willing to cooperate fully and provide any necessary information to aid in the investigation.
