Myself Kumkum Chakraborty, W/o. Tanmoy Chatterjee, D/o. Sunil Chakraborty, R/o. Kawakhali, new township, P.O. Shushrutanagar, P.S. Matigara, Dist Darjeeling, Pin- 734012.

That on 2017, in the month of January, one information of groom namely Tanmoy Chatterjee was received to my parents by one local catalyst or matchmaker of jiyaganj who is known to me namely as "Manosi Singha Roy", she is a permanent resident holder of Sadar ghat, Leubagan, Jiyaganj, Murshidabad. She described us completely false information about groom and his family that they are belonging from a very good and normal family, groom is the only son and his only sister is already married. His father is retired locopilot. Highly educated and we'll established family. Groom has his own business. They showed us up two shops in jiyaganj, one is tea-leaf shop and cosmetics product's shop is another one and said that both shop are belongs to groom.

Then some relatives from groom side had come to our house for finalise the marriage. They are Ashish Chakraborty (Maternal Uncle of groom), Timir Chatterjee(Father-in-law), Tanmoy Chatterjee(Groom), Shukla Chatterjee(Mother-in-law), Tanushree Sarkar(Sister-in-lae) & Prasanta Sarkar), they described about my bright, strong, smooth and better future with them. The relationship was grew up with the following of Mrs. Manosi Singha Roy repeatedly. Then one socially arranged marriage was established in between us on 13/03/2017 and I went to jiyaganj and started to live with Tanmay Chatterjee as husband and wife.

In 1st night, they made me busy in so called rituals and didn't allow to meet or stay with my husband as my relatives were also present there in jiyaganj. After two to three days, when they returned back to Siliguri, my in-laws allowed me to stay with my husband. In that time, on 1st night I saw some abnormalities in the behaviour of my husband. I couldn't get understand anything, but day by day



I came to know that my husband is a fully devil in nature, he acts like demon and habitual of daily routine wise medicines. But my in-laws denied to hand over me the medicine he took. Gradually I came to know that he is a man evil in nature and has some neurological problems who used to torture me mentally and physically. After knowing this as I asked to go to my maternal aunt house, my in-laws started to treat me very brutally. They stopped my waying out from the house and broke my phone also that I couldn't contact with my parents. In between this, I came to know that I have conceived. I was sexually tortured by my husband without my will as he used to act like a monster. They even don't allow me to give this news to my parents. And they have tried to abort and terminate the pre-mature baby without my will. Also during pregnancy my husband tortured me mentally, physically and sexually and in this circumstances my father and mother-in-law used to help him by giving many kinds of medicines. On 13/01/2018 my son was born.

After my delivery, as I returned back to home from nursing home, my husband forced me to do sexual intercourse. As I denied he pushed me down from the bed and the stitches of my "C" section have teared. I cried in deep pain then they again took me in hospital and again done stitches.

That after few days, I somehow made contact with my parents and described all the matter briefly. With the initiative of my parents, on 26/04/2018 they returned bring me back to my parental house in Siliguri as it was life threatening manner to me. Then after few days my in-laws came to my parental house and assured us that from then my husband would stay with me in Siliguri as "Gharjamai". And from then we started to stay in my parental house as husband and wife.

That after some days, I came to know that my husband has nothing and which two shops they showed us up before marriage those are not belong to my husband, they made completely false information before marriage to us to gain our trust and faith and completely cheated us. My husband is a fully illiterate and uneducated person although my in-laws and catalyst described us before marriage that my husband is a graduate person. They repeatedly had done fraudulent activities with me and my family. The catalyst namely Manosi Singha Roy has completely cheated and spoiled my life by making completely false information in greed of a gold earring from my in-laws. Day by day, their torture, brutality and devil manner has grown up. Then my husband started to torture me mentally and physically assaulted me repeatedly in my parental house. Seeing these my parents contacted with my in-laws and described the matter to them. They completely denied that their son could not do anything like these. Then on the end of the month of august 2023 all the above mentioned in-laws and that above named catalyst visited our house in Siliguri. Then they all have physically assaulted me in my parental house and forcibly took me away



from my parental house along with my husband and son to jiyaganj at their place.

Lastly on 30/09/2023 at about 5 P.M. my husband and his above mentioned family members tried to kill me as my as my elder brother went to Jiyaganj in my matrimonial house to meet with me, at first they have told my mother and elder brother that I'm not in home but this information was totally false. After then when I wanted to contact with my mother and elder brother the whole family gathered one by one and physically assaulted me very brutally hit my head in the wall by pulling my hairs which become life threatening to me. Somehow I escaped from there and ran away in the road and called my elder brother from the phone of a passing by person to rescue me. Then my elder brother rescued me from there and took me in Siliguri. But my health condition was too bad as I starved from a long days in my matrimonial house. Then on 07/10/2023, I went to Siliguri District Hospital for further treatment but I was not able or mentally and physically was not fit to lodge F.I.R or further fights.

Now I'm better than before and able to fight for the justice. Finding no other alternatives, knocking at your door and requesting you to do the legal needful.
