Respected Sir,

With due respect, I, Sudeshna Majhi, daughter of Anil Majhi, presently residing at I No. Dabgram, nearby Polytechnic College, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, beg to inform you that I had a puppy, aged about 2 (two) months from the German Shepherd bread.

On 10.01.2024 my puppy got ill having a stomach upset around 9 o'clock in the evening, as its health condition was deteriorating I decided to consult a Veterinary Doctor and I came to know that there is a pet shop and kennel under the name and style of "Jennelie's Pet Shop and Kennel" owned by one Priyanka Majumder, daughter of Prasanta Majumder, resident of Rabindra Nagar, Bakultala More, P.O. Rabindra Sasrani, P.S. Siliguri, Dist. Darjeeling, I called her over phone and enquired about a good veterinary doctor, she assured me that they is a registered druggist having a licenced veterinary practitioner who sits and attends patients from her shop and every medical facility in respect of animal was available at her place, hence I took the puppy there and a person inspect the health condition of my puppy and started treating it.

Inspite of the 1st day's treatment and medication prescribed by a person present at the said pet shop who introduced himself to be a veterinary doctor, there was no improvement in the health condition of the puppy rather it was deteriorating time by time on the next day saline was administered upon it alongwith other medicines but the puppy started vomiting as well alongwith loose motion.

It is pertinent to mention here that the puppy was under the treatment and care of "Jennelie's Pet Shop and Kennel" from 09.01.2024 to 11.01.2024, throughout this time I have noticed that she was trying to put many medicines on the puppy and the prices she was charging against those medicines was much higher than the MRP on those products which I noticed later on, inspite of asking for bills many times she initially used to roll over my request saying that the bills would be provided altogather at the time of final billing, but ultimately she refused to provide any bills when I decided to bring back the puppy from her establishment, she charged approximately Rs. 31,000/- (Rupees thirty one thousand) in those three days.

Thereafter I took my puppy to another veterinary doctor and there I came to know that my puppy was subjected to wrong treatment, then I started enquiring about "Jennelie's Pet Shop and Kennel" thoroughly, on such query some shocking facts came to my knowledge like there was/is no veterinary doctor associated with the said shop, the person who treated the puppy is one Chetanraj Roy, who is a fake doctor, on more query I came to know that this Chetanraj Roy is only 8th standard passed in qualification, this is how said Priyanka Majumdar is cheating common people and illegally running the business of pet shop, dealing drugs without the mandatory provisions and documents.

On 14.01.2024 my puppy died as because it could not overcome the wrong treatment and somehow said Priyanka somehow came to know that we have the knowledge regarding her wrong doings, she alongwith her boyfriend, Prasenjit Dey, C/o "Jennelie's Pet Shop and Kennel", have started threatening us started over telephone, she also threatened us to implicate in a false case.

Later I came to know there are many complains regarding her ill-treatment which amounts to cruelty over animals.

Said Priyanka Majumdar is the mastermind behind every illegal, cruel activities as well as the activity of cheating by personification of a veterinary doctor.

In view of the above facts you are, therefore, requested to investigate into the matter and take immediate necessary action against the culprits.
