I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Bijay Sarkar, S/O - Gouranga Sarkar, Spl Jail Khana Road, Near Local bus stand, Subhaspally, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 16.01.2024 at about 03.40 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the Commercial shop of Bijay Sarkar and inspected service installation, metering installation of Consumer ID 400046445 in the name of Sri Subrata Dhar. During inspection it was found that electricity was being used unauthorisedly & illegally by Bijay Sarkar by reconnecting the disconnected service line of the metering installation that was disconnected previously on 08.07.2022 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make HPL Electric & Power Pvt Ltd, serial no.- H00101250 installed against Con Id. 400046445 seized by preparing a formal seizure list duly signed by Bijay Sarkar and witnesses. The copy of the seizure list handed over to Bijay Sarkar and his signature obtained as token of receipt.

As Bijay Sarkar have committed offence u/s 135(1)(e) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR.
