**Sub:- F. I. R. against unknown miscreant/(s) for house trespass and mischief.**

Sir,  
I, Sri Pranab Sikdar, son of Late Manindra Mohan Sikdar, resident of Phani Bhusan School Road, New Milanpally, Ward No. 25 of SMC, P.S. Siliguri, Dist: Darjeeling, do hereby lodge this complaint against unknown miscreant/(s) to the effect that last night i.e; 15/16/01/2024 unknown miscreant/(s) entered into my premises and destroyed some electric wire of my undergoing construction which are being used for electrification with an intention to causing mischief.

The cost of the damaged wire approx Rs. 15,000/- (Rupees Fifteen thousand) only. The incident was detected this morning i.e; 16.01.2024. Parts of the cutting wire also kept in a corner of a room. Enclosed photograph for your ready reference.

Apart from that I like to mention here that a dispute is going on with my neighbor Sri Netai Roy for the last few month over the issue of removal of some trees which are causing great annoyance to us and an order has been promulgated by the Ld. Special Executive Magistrate, Siliguri for the removal of the said trees in connection with the Petition Case no. 63/2023.

As such, the involvement of my neighbor Sri Netai Roy and his family members cannot be ruled out against this incident.

Hence, you are requested lodge an FIR under proper section of law and arrange for its investigation in order to book the miscreant/(s) involved.
