It is to be noted that on 10.02.2022, I surrendered the saving account being No: -9645247443 of Kotak Mahindra Bank, Hill Cart Road, Siliguri, Dist.: Darjeeling along with Cheque book, ATM Card etc in my name. on 13.01.2024 My adjacent Flat Co-Owner Mamta Maheswari received one Legal Notice in the name of me as I was at that time out of station but thereafter, she given the same in my hand where from I noticed that one Swapan Kumar Ram [Advocate] of Surya Sen Colony, Block-B, Opp. Surya Sen College, P.O. Siliguri Town, P.S. New Jalpaiguri, Dist.: Jalpaiguri 734004 send me a Legal Notice U/s 138[b] of N.I Act, alleging that due to cordial relation I approach said Pawan Kumar Gupta for financial assistance for Rs. 5,00,000/- [Five Lakh Only] and said Pawan Kumar Gupta also provided a total sum of Rs. 5,00,000/- [Five Lakh Only]. The copy of the said notice is annexed herewith as Annexure: B. I never approached him any money or any point of time so question of provided of Rs. 5,00,000/- [Five Lakh Only] doesn't arise at all.

I again mention you that I never issued as Cheque of Rs. 2,00,000/- [Two *Lakh Only] being Cheque No; 000008 dated: 23.11.2023 of Kotak Mahindra Bank of Hill Card Road, Siliguri Branch, in Favor of Pawan Kumar Gupta, my strong belief is that when said Pawan Kumar Gupta and I jointly run our business then I was not into a lot of Business activities/Meetings as because I had a minor kid to look after at that time I used to keep my signed cheque in my drawer for urgent needs taking the said advantage Pawan Kumar Gupta stolen the said cheque in the year of 2022. That in the month of January, 2023 I have lodged an aforesaid criminal case against Pawan Kumar Gupta and his sister Priyanka Gupta and since then I have a strained relation with

him and his sister, so there is no chance for issuing any cheque in the month of November, 2023 because prior to lodging of this aforesaid case the account was already surrendered/closed along with all the documents, i.e., on 10.02.2022.
