I, Adrija Kundu, wife of Nilatpal Choudhury, presently residing at of Sankar apartment, Aurobindopally, backside the house of Samar Biri Factory, Rabindra Sarani P.S Siliguri District Darjeeling, would like to inform you that I was married toNilatpal Choudhuryson of Late Swapan Choudhury, resident of Ashutosh Mukherjee By lane, Collegepara near Children Park, P.S Siliguri District Darjeeling, on 13th Day of December, 2016 and the said marriage is a love cum arrange marriage. That it was on the insistence of my husband, that I agreed to the said marriage. That before marriage I was a trained Kathak, Bharatnatyam Dancer, including all semi classical dances and it was my condition before marriage that I will continue my dance training classes. However, after marriage all my dreams shattered as I noticed an indifferent behaviour on the part of my husband and my mother in law namely, Anjali Choudhury. On and off my mother in law namely, Anjali Choudhury and my husband used to throw their tantrums on me, made me do all the household works, did not give me enough food to eat and used to say that sufficient household items, Car etc have not been given at the time of marriage. That after twenty days of marriage my husband said that enough furnitures have not been given in marriage and demanded a dinning table, sofa set along with car from my father and when I protested against the same, my husband had physically assaulted me with kicks and blows and I reported about the same to my father and my father for my happiness fulfilled their demand by buying sofa set and dinning table and delivered the same to my matrimonial house. Even after that, my husband and mother in law was not happy, My husband refused to pay for a single farthing to me and I have to leave my dance class as I was reluctant to ask money from my father. That at night regularly my husband used to do mental torture on me shouted at me and sometimes even physically tortured me, even sold some of my gold ornaments not even telling me, not being able to bear the day to day tortures, I started having serious health problem like panic attacks and went into depression. That on 24/3/2017 my husband thereafter kept me in my father's house and left me. That I was shown to doctors by my father and was told that I due to such mental and physical tortures, I have become a physiological patient. That my father showed me to various doctors, but my husband did not bore a single expenses. After showing to various doctors about three years later, I had recovered to certain extent, when my husband and his various friends came to my parental house, started pressurising me to live with him and apologised for his conduct from me and out of various pressures I agreed, he took me to a rented house, where inspite of knowing that I was having various medicines, he made me

pregnant, inspite of being warned by doctor not to make me pregnant as it might be a risk for the child as well as me. That after I became pregnant, my husband refused to bear any expenses and kept me in my parental house on December 2021 and returned to his parental house. That during my pregnancy my husband was least bothered and I thereafter, gave birth to a child on 17/8/2022. After the birth of the child my husband had come to see the child but he did not provide a single expenses for the maintenance of my child or me, on the other hand my husband started demanding money of Rs 2 lakhs from my father stating he urgently requires the same to which when my father denied to pay, he stopped having any talking conversation with me and my family. That since more than oneyears I am in my parental house having no relation with my husband. That on 16th January, 2024 at 9:20 pm my husband came to my parental house and said to me that if I wanted to live a conjugal life with him, my father has to fulfil his demand of Rs 2 lakhs otherwise he shall not have any relation with me. That when I refused that my father will not pay him a single penny and I too donot want to live a conjugal life with him, he became furious and started hitting me with kicks and blows, when my mother came to my rescue, he ran away stating that he will see how my parents and I stay in the locality, that there is immense threat to my life as well as the life of my parents and my brother, as earlier also my husband along with his friends had threatened my family members by various means.

That I therefore request you to inquire into the matter and take necessary action against want to my husbandNilatpal Choudhury and my mother in law, Anjali Choudhury.
