With due respect that I, ANTHONI LAMA, S/o Late Dorjee Lama, R/o. Mira Niwas, Narmada Bagan, Champasari P.O. Champasari, P.S. Pradhan Nagar, Siliguri -734003 would like to draw your kind attention as follows-

That I am a driver by Profession and also member of "Siliguri Junction Drivers & Workers Union", Affiliated by I.N.T.T.U.C. I stand my car in Siliguri Junction near Bharat Petrol Pump and carrying passengers from Siliguri Junction Stand to Darjeeling, this is the only source of my income to run my family. But one namely Lucky Chand Paswan, son of Dinuwa Paswan, Resident of Pramod Nagar back side of Commissionerate of Police Office, Ward No- 47 Dist- Darjeeling, he is not even member of the above mention Union. Every day he came to the Siliguri Junction stand with his vehicle whenever he want and then he started forcefully snatching other driver's passengers when we try to protest against his this unethical behavior, he always abuse every one with filthy language and threatened everyone that he will broke the glasses of the vehicles and will broke the hands of those drivers who will stop him and sometimes he even threatened the passengers.

Today he repeating the same pattern and came to the Siliguri Junction Stand around 2 P.M, when I was loading passengers in my vehicle the said Lucky Chand Paswan came in front of my vehicle and ordered me to vacate my vehicle but when I refused to do that he abuse me and try to hit me, others drivers who were present at that time they were protest then said Lucky Chand Paswan and save me and handling the Situation. We said we will call the Police so on that time he left form there.

But after sometime around 4 pm he came back again and suddenly he attacked me from the back side of mine and stab me with a Sharp knife on my head, on that time I grab his hand and the knife he continuously shouting that he will kill me. Then he punched me and I fell down on the ground and continuously he hit me on my face by fist and blow and he was shouting that "I will kill you" and again he try to stab me with the knife but on that time everyone gather and hold him and some of the driver inform the police officer and also call the traffic police, one Pradhan Nagar Police van came to the spot and rescue my life from the hand of said Lucky Chand Paswan.

But on that time I got unconscious and some of people of the stand those who were present on that time they took to the District Hospital for treatment, But right now I suffer severe bodily pain and grievous injury in my head, eye and all over my body.

Therefore, Being a law abiding citizen of India I came in front of you and I request to you to kindly take a necessary step so that the accused person is got punished.
