Sir,

In producing herewith arrested accused person named Rambrij Roy, of - Kawakhali Bazar, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling along with copy of memo of arrest, seizure list and seized articles viz 10 (Ten) Sealed Himalayan Gold 60 Up Bottles Country Spirit each containing 375 Ml @ Rs. 100/- each totaling amount of Rs. 1000/- marked as exhibit "A" and one bottle taken as sample.

The fact of the case is that today on 21.01.2024 at 20.10 hrs received source information that one Rambrij Roy (64 yrs), S/O- Late Lalu Roy, of - Kawakhali Bazar, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling have stored huge quantity of ID liquor at his house at Kawakhali illegally for sale to the People for his wrongful gain.

I informed the matter to O/C NBMC OP and as per his direction I along C/340 Pranab Adhikary of - NBMC OP under Matigara PS, C/463 Debasish Sarkar, of - SAP4th Bn, Kasba Raiganj, camp at NBMC OP left for Kawakhali to work out the information. At about 20.35 hrs held raid at the house of Rambrij Roy (64 yrs), S/O- Late Lalu Roy, of - Kawakhali Bazar, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling and on search 10 (Ten) Sealed Himalayan Gold 60 Up Bottles Country Spirit each containing 375 Ml @ Rs. 100/- each totaling amount of Rs. 1000/- have been recovered. On demand he could not produce any documents / License for possession such quantity of I.D liquor. On interrogation he admitted that he stored the said I.D liquor illegally for sale to the interested persons for his wrongful gain.

So, I seized the said 10 (Ten) Sealed Himalayan Gold 60 Up Bottles Country Spirit each containing 375 Ml @ Rs. 100/- each totaling amount of Rs. 1000/- in presence of witnesses under proper seizure memo and arrested him U/S 41 Cr.P.C. The search seizure and arrest was made in between 20.45 hrs and 21.00 hrs.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Rambrij Roy (64 yrs), S/O- Late Lalu Roy, of - Kawakhali Bazar, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling and kindly arranged for its investigation.
