Furthermore, upon such representation we had placed an order with him for Two Gensets of 250 KVA and has given him an advance of Rs. 200000/-(Rupees Two Lacs) Only vide Cheque No 111290 drawn on our Central Bank of India Bank, Sf Road Branch, Account No.3463549010 Dated 04.04.2023 which we believe was therein was encashed by him in his bank account maintained with ICICI Bank on 6.04.2023. During this course of time I came to know from a · reliable source that he was NOT an Authorized Dealer of "GREAVES COTTON LTD", and hence we confronted him and requested him to Refund of the advance Money paid to him by Advanced Developers. He willingly had agreed he had made a mistake of misrepresentation to us and assured us that would refund the advance token money of Rs. 200000/-(Rupees Two Lacs) Only vide Cheque No 111290.

He kept on promising to refund the taken amount time and again with multiple dates thereby simply buying time. Finally, upon several visits to his office at 4loor, International Market, Sevoke Road office, he issued us a Cheque No. 000234 of ICICI Bank Account which failed to encash and the said Cheque Bounced due to Insufficient Fund on 21.10.2023 as reflected in the Company Bank Statement.
