Darjeeling, Pin 734005, beg to respectfully submit that I am a practicing lawyer of Siliguri Court and I am also a member of Siliguri Bar Association. Mention here that one Sri Ajay Kedia (aged about 50 yrs.) Mobile: 9474935146, 9832489101, S/o. Sri Sitaram Kedia and Smt. Soni Kedia (aged about 45 yrs), Ph: 98005 824351), W/o. Sri Ajay Kedia both are resident of C/o. Sita Ram Kedia, "KEDIA SADAN", M.G. Road, Khalpara, Ward No. 7 of SMC, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling, Pin 734005 and their another address is B-0108, City Centre, Uttarayan, P.O. & P.S. Matigara, Dist. Darjeeling, Pin 734010 both are big property Dealers of North Bengal area. Both husband and wife i.e. Ajay Kedia and Soni Kedia came to my chamber since quite someday before and they gave me their several tasks/works of my legal profession like (1) Five Nos. City Centre's shop rent agreement (2) Ten Nos. Land sale-purchasing agreement, (3) Five Nos. Land searching work (4) Professional Legal advice for one legal notice send by Smt. Sarita Pradhan, D/o. Ramu Pradhan, to Ajay Kedia regarding demand of huge amount along with all original valuable documents on 25/05/2023, since then they used to come to my chamber frequently for their legal professional works which they used to give me and they also gave the work of buying and selling several lands, and on 12/12/2023, they came to my office and delivered some Xerox papers of land deed and other papers for registration of a commercial Shop measuring 921 Sq.ft., Unit No. CESGB0108, situated on the 1st Floor, of City Centre, Matigara, in their favour worth Market Value of Rs.77,42,962/- (Rupees Seventy Seven Lakhs Forty Two Thousand Nine Hundred Sixty Two) only, Stamp duty paid Rs.,2,32,309/- (Rupees Two Lakhs Thirty Two only, Registration Threë Hundred Nine) Rs.77,444/- (Rupees Seventy Seven Thousand Four Hundred Forty Four) only, User charge paid Rs.500/- (Rupees Five Hundred) only, i.e. total amount expended/deposited @ Rs.3,10,253/- (Rupees Three Lakhs Ten Thousand Two Hundred Fifty Three) only, in favour of Sri Ajay Kedia and Mrs. Soni Kedia, and registered the same vide deed No. I- 9622, book no. 1, year 2023, date of registration 21/12/2023, registered before A.D.S.R. - Siliguri - II, at Bagdogra, Dist. Darjeeling.

Mentioned here that for previous outstanding works fees Rs.40,000/-(Rupees Forty Thousand) only and above shop registration fees Rs.35,000/- (Rupees Thirty Five Thousand) only, i.e. total Rs.75,000/-(Rupees Seventy Seven Thousand) only, was owed to them but they only paid Rs.29,747/- (Rupees Twenty Nine Thousand Seven Hundred

Forty fleven) only, out of total outstanding dues of my professional works fees Rs.75,000/ (Rupees fleventy Five Thousand) only, and Ps. 45,253/- (Rupees Forty Five Thousand Two Hundred Fifty Three) only, still I get it from them. But they did not pay my dues instead repeated asking but instead of Mrs. Soni Kedia has filed a false case against me vide Matigara P.S. Case No. 12/2024, dated 4/01/2024 U/S 406/420 of IPC and on 10/01/2024 I got bail from Lt. A.C.J.M. at faliguri but still they i.e. Ajay Kedia and Soni Kedia threatened me with dire consequences and also threaten that they will kill me if I do not follow their words and in order to tarnish my image, they have given this false story to one News Paper namely Uttar Banga Sambad, dated 08/01/2024 and in Face Book Page of Ajay Kedia on 06/01/2024, in this situation I live with my old aged parents in fear of them. I also afraid, they may even kill me for fear of giving money to me.

In such a situation, strict measures should be taken as per the Indian Penal Code against the above guilty persons namely Ajay Kedia and Soni Kedia, who directly involved in the conspiracy after proper investigation.
