I, the undersigned, Nikita Chanda, wife of Sujit Chanda, of Kawakhali, near North Bengal Medical College, Darjeeling-734012, would like to state the following facts to register my complaint before you.

My husband Sujit Chanda, a CRPF personnel, has been fereived constructing a house in and over a piece of land near Desun केत 22.01.24 Hospital, Matigara. In process of construction, my husband had of 14: 05 As ordered crushed stones and it was unloaded yesterday at 9:15 ordered crushed stones and it was ordered the ordered by the Fine pm. However, when the truck loaded with stones reached the 511 of 22/1/24 spot of the construction, some miscreants and constructionthe original material-mafias of the locality stopped the driver from unloading omplant material-mafias of the locality stopped the driver from unloading Capy forward the stones and demanded rupees 6 lakhs (Six Lakhs), otherwise to 1/c M.T. they would not let the construction take place. After a first fully conversation with my husband the driver was, anyhow, allowed care under to unload stones.

proper Section Thereafter I along with my husband reached there to talk ndarra with the people obstructing construction. They are local people 15 Governmend Khitish Adhikary, son of Khirod Adhikary, Bhupen Singh, figure of Luv (title not known) Luv's mother (name not known), and two other persons (known to me by face). Since the very inception of the construction of the house, these five people have been obstructing the construction in various ways.

All property side to talk to him and suddenly started beating him with fist and side of the started beating him with fist and side of the started beating him with fist and sister. Those slangs could not be spoken in civilized society. They were

carrying bhujali and iron rod and tried to kill my husband. My husband, due to their sever attack, lost his balance. They were shouting that they would not allow my husband to construct the house over there. I and my brother-in-law tried everything possible to protect my husband from the clutches of the miscreants but they pushed me and hold me by clothes and tear my clothes and passed sexist remarks against me. Bhupen Singh, specifically threatened me that if my husband does not stop construction, even our dead body would not be found. Due to such severe attack the mobile of my brother-in-law was damaged, and my husband got severely injured. I and my brother-in-law took him out from there and directly reached to the North Bengal Medical College & Hospital for his treatment as he was bleeding, fainting and vomiting continuously throughout the way to reach the hospital. He has been treated with stitches in his face. My husband is serious and undergoing treatment at the hospital at present. I have two small children of tender age and such threat to life and limb of my husband can ruin the life of whole family. They are threatening to kill all of us if we dare to lodge any complaint before police authority.

I request you to kindly accept my complaint immediately and take strong action as soon as possible and arrest the culprits for the ends of justice. I also pray before you to record the statement of my husband, admitted in the NBMCH, as soon as possible.

And for this act of duty I shall be highly obliged to you.
