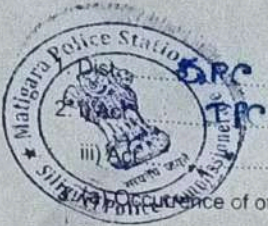

Dear Sir,

I am writing to bring to your attention a distressing incident that occurred on 22.01.2024 at 09:55 AM, involving an assault on me by two unidentified individuals. I am seeking your assistance in lodging a First Information Report (FIR) against the perpetrators.

I am employed at the Siliguri Suburban Division Office, WBSEDCL, Shivmandir. On the mentioned date and time, while I was on my way to the office, I encountered a roadblock caused by two individuals driving cars, one with the registration number WB74AV8999. Despite my attempts to navigate around the obstruction by blowing my bike's horn, the individuals refused to yield.

Subsequently, the situation escalated as they pursued me for approximately 500 meters. They forcibly removed the key from my bike, causing damage, and manhandled me. They even attempted to force me to remove my helmet, but I managed to resist. Fortunately, my helmet provided some protection for my face and head. Despite the intervention of concerned civilians, the attackers remained unresponsive.

This incident has left me in a state of distress, and I could not fulfill my duty of providing biometric data at the office on time. In light of these circumstances, I kindly request you to initiate the process of lodging an FIR against the two unidentified individuals responsible for this assault.


