Respected Sir,

With due respect I the undersigned would like to inform you that I have entered into the marriage with Sri Indrajit Karmakar, S/o. Late Biswanath Karmakar, of Shibram Pally, Opposite Vibgyor Art School, Ward No. 39 of S.M.C., P.O. Haider Para, P.S. Bhaktinagar, Dist. Jalpaiguri and said marriage was solemnized at Siddheswari Kali bar, S.F. Road, Siliguri, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling on 07.08.2016 according to Hindu Rites and Customs and said marriage was registered according to Hindu Marriage Act before the Ex-Officio Marriage Registrar, Siliguri on 03.02.2017. At the time of the said marriage my parents and my family members have given gold ornaments, furniture, house hold articles, garments and a sum of Rs. 5,00,000/- (Rupees Five Lac) only in cash on demand of my husband. On 08.08.2016 I was brought to my matrimonial house by my husband and I have also brought my all stridhan properties and entrusted those articles to my husband, my brother-in-laws Sri Sanjib Karmakar, Sri Biswajit Karmakar and Gopal Chandra Karmakar and wife of Sri Gopal Chandra Karmakar namely Smt. Geeta Karmakar.

I would like to further inform you that after elapsing of few days from the date of said marriage I found that my husband had an extra marital relation with my younger sister-in-law Smt. Geeta Karmakar and some time I caught them in red hand and my husband had promised me that he will not continue the said illicit relation with said Smt. Geeta Karmakar and he had requested to me not disclose the matter to my family members and he had also promised me that he would lead a happy conjugal right with me without any further complaint and on good faith being a newly wedded wife I had forgiven him and we started our conjugal life and out of the said wedlock I gave birth a female child on 22.03.2018 and a male child on 31.05.2021.

I would like to further inform you that after the birth of my son, I have noticed that my husband has again started to mixup with my said sister-inlaw and on several occasions I found them in compromise situation in my matrimonial house and whenever I made protest against the said illegal act of my husband and my said sister-in-law, my husband with the instigation of his other three brothers used to assault me brutally and on several occasions I sustained serious injury and sometimes my husband and his

three brothers used to say that my said sister-in-law is enough competent to give physical enjoyment to them as because my elder two brother-in-laws did not enter into the marriage and my husband ought not to enter into the marriage with me and they all are happy with my said sister-in-law sexually and such type of behavior caused the serious mental trauma to me.

I would like to further inform you that from few months my husband has stopped my maintenance even also refused to provide food to me and my minor kids with the allegation that I have stolen the fish from kitchen and they did not allow me to enter into the kitchen for making food of my minors and most of the days I have started to feed my minors by purchasing first food like chips, cake, biscuits by taking the money from my younger brother. On several occasions my husband and my brother-in-laws told me to leave my matrimonial house as because I am very unlucky for their business. But all the relevant time I have swallow all the pain for considering the future of my minors and I had / have never open my mouth for also avoiding my social status and prestige.

I would like to further inform you that today in the morning at about 11:00 AM my husband suddenly caught my neck and started to throttle by a curtain of the window but somehow I have managed to skip from the hands of my husband and I started to run from up stair but he assaulted me by kick and blow from behind and somehow I left my matrimonial house with my daughter by a single wearing and took shelter in my brother's rented house. That my husband and in-laws continuously tortured upon me both mentally and physically and the said quantum of torture is now unbearable and I have no other option but to lodge the present complaint.

Under the above circumstances I would like to request you to investigate the matter and do needful for the ends of justice.
