The Complainant states that he never attached with the "INDRA ENTERPRISE" or with the premises no 707-Sarvapriya Apartment, INTERNAL ROAD, Opp 12/1,15/15 Sarvapriya Vihar, New Delhi, South Delhi-110016, never transacted the sum of Rs.1,70,71,953/- as shown therein.

That Your Complainant states that he never do/did any business, applied/taken any GST No and not done any short of transaction at any point of time, not only that never he was the beneficiary of the said High Value transaction.
