Sir,

I, Ranadip Mazumder, Son of Lt. Kalipada Mazumder, A.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against **Sri Krishna Ghosh S/o Sri Chandan Kr. Ghosh (Ph- 9026763813)**, having address Shastri Nagar, Ward No-41, Near Hansbela Ashram, P.O. – Sevoke Road, Siliguri, Dist- Jalpaiguri, P.S Bhaktinagar, Pin-734001, West Bengal.

While on a routine inspection on the site having consumer id 412150759, meter no A1000920177533, having power connection of WBSEDCL in the name of **Chandan Kr. Ghosh (Ph- 8016682960)** in the address being Shastri Nagar, Ward No-41, Near Hansbela Ashram, P.O. – Sevoke Road, Siliguri, Dist- Jalpaiguri, P.S Bhaktinagar, Pin-734001, West Bengal, I, Ranadip Mazumder, Assistant Engineer & Station Manager, Power House CCC along with Md Azharuddin, Junior Engineer, Grade-II, Power House CCC, WBSEDCL and other technical staffs observed that the energy was being used unauthorizedly bypassing the incoming Service Cable of Energy Meter.

We entered the premises at 11:50 hrs on 24.01.2024 after handing over Notice to Sri Krishna Ghosh present during inspection. Then it was observed that the power was being used unauthorizedly bypassing the Energy Meter. Therefore committing a crime for theft of power as per section 135 (1) (a) of The Electricity Act 2003 amended on 2007 of India. Physical load of equipments used were 2.20 KW whereas contractual demand is 1.18 KVA. Accordingly the connection was disconnected and the energy meter and service cable were seized and labelled. A copy of both inspection report and Seizure list (1. CMS make, 1 Phase, 240 Volts, 5-30 amps, SI No A1000920177533 with Last Reading-9877.5 KWH, property of WBSEDCL, 2. Aluminium Service Cable of 2 core 4 Sq mm of 15 meters approx along with bypassing arrangements) were handed over to Sri Krishna Ghosh present during inspection. We exited the premises on 12:25 hrs.

Thus you are requested to kindly initiate an investigation against **Sri Krishna Ghosh** under Section 135 (1) (a) of the Electricity Act 2003 amended on 2007 of India.
