Subject: Complaint against unauthorized shifting of LT O/H line

On 28.01.2024, complaints were received from the residents of new Pokhaijote, near Kali Mandir, at around 6:00PM, regarding no power and meter burnt in that area.

LT mobile van of Pradhannagar CCC attended the spot and found that the LTOH line of a span between 2 poles has been shifted illegally by some unknown persons to another adjacent pole. To restore the power to the complaisance necessary steps were taken but the shifting was not reversed and was left as found.

The U/s visited the spot on 29.01.2024 along with technical staffs of Pradhannagar CCC and found that the LT O/H line of a span between 2 poles has been shifted illegally by some unknown persons to another adjacent pole.

Before shifting, the LT O/H line used to pass over the domestic premises of Ramen Chandra Barman(Con Id-412228953, Meter No-L0756984) and Pawan Kumar Sah(412266103, Meter No.-L0894063).

Ramen Chandra Barman and Pawan Kumar Sah denied having knowledge as to whosoever had done the shifting.

Prima-facie it is apparent that Ramen Chandra Barman and Pawan Kumar Sah are the sole beneficiaries of this shifting, as this has led to removal of the LT line passing over their premises. Local people said that the work had been done at around 5:00 AM on 28.01.2024 by a group of 5 to 6 men.

Under this circumstances, the U/s requests you to investigate the matter as to find the persons responsible for illegally and unauthorized tampering with the LT infrastructure of WBSEDCL and endangering the life and property of the common public, under section 139,140 and 141 of Electricity Act 2003 read with amendment 2007.
