Dear Sir,

With due respect I the undersigned would like to inform you that I could recall from my memory that in the month of June, 2019, I met with one Smt. Antara Bhowmick and she introduced herself as a manager of 'creative studio' having its office situated at near Jalpaimore, Siliguri - 734005. After the said meeting and introduction we carried a friendship relation for few months. After elapsing of few months we proposed each and other and with the consent of our both the family members we have decided to enter into the marriage and we have registered our marriage on 14.05.2021 before the Marriage Officer, Siliguri.

I would like to further inform you that on 28.06.2021 our marriage was solemnized according to Hindu rites and customs in the maternal house of my wife at Deshbandhu Para, P.O. & P.S. Siliguri, District-Darjeeling and after the said marriage I brought my wife in my place at East Chayan para, P.O. – Ghogomali and P.S. – Bhaktinagar, Dist – Jalpaiguri and we started to live together as husband and wife in the joint mess with my widow mother and my only unmarried sister.

I would like to further inform you that before the panchayat elections, 2022 my wife has requested me to enlist her name in the voter list and for that she has handed over me some copy of documents relating to her PAN Card, Adhaar Card, Birth Certificate, Educational Certificates and as per my convenience I went to the office of the B.D.O., Fatapukur and as per the rules and regulations for the enlistment of a new voter, I have submitted the photocopies of those documents to the official of the concerned authority but I was shocked when the said officials informed

me that the Educational Certificates of my wife are false and the name of the father of my wife is different as shown in the birth certificate of my wife as 'Shibu Bhowmick' and shown in the Aadhaar card as 'Uttam Bhowmick' and ultimately those documents were returned to me by the said officials and advised me to furnish the proper and original documents of my wife for listing her name in the voter list.

Due to the said illegal act of my wife I felt very humiliation before the said authority and said act has given me the mental trauma and after returning the house I have searched the file of my wife and I found two documents relating to the progress report of my wife in which I found that my wife has passed out class 7 and 8 final examination in the year 2014-15 and 2015-16 respectively from 'St. Paul School', Bidhannagar but as per the Secondary School Examination, 2016 and Senior Secondary School Examination, 2018 has been passed by my wife on 29.07.2016 and 27.07.2018 respectively and on searching I found that the said 'Board of School and Technical Education' is not enlisted in our education system and all those documents are manufactured and forged and it is very surprising that if my wife passed her class 8 examination in the year of 2015-16, how she passed the secondary examination on 29.07.2016.

I would like to further inform you that thereafter I asked my wife that why she manufactured those documents and submitted those documents before the various government authorities for preparation of Aadhaar card, voter card, PAN Card, bank account and other documents then on reply she told me that her mother Smt. Chhabi Rani Bhowmick left her husband Shibu Bhowmick in her childhood and her mother entered into the second marriage with one Sri Deepayan Roy without dissolving the first marriage and started to reside at Subodh Apartment, Deshbandhu Para P.O. & P.S. Siliguri, Dist. - Darjeeling and those documents of secondary and senior secondary educational certificates were obtained by my wife with the help of her mother and her second father for getting the job.



I would like to further inform you that being a prudent and responsible husband, I have requested my wife not to carry those illegal and purported documents further and not to use those documents and other documents like Aadhaar card, voter card, PAN Card, bank account and other documents in any official purpose but my wife misbehaved with me and called her mother and second father and they all have threatened me with dire consequences and told me that if I will disclose the same to any authority, they will give me a remarkable lesson. After the said incident, my wife has started to ignore me and I found that she has started an extramarital relation with one Avijit Biswas and I found that she started to spent a considerable time with him after her working hour and I used to swallow all the said mental pain for avoiding the future complications and hazard and social reputation as because I am a State government employee and my mother is an aged woman suffering from various ailments and marriage of my sister is yet to given.

I would like to further inform you that on 12.10.2023 my wife has taken away the valuable gold ornaments amounting worth Rs. 2,50,000/-(Rupees Two lakhs Fifty Thousand only), valuable household articles and a sum of Rs. 3,20,000/- (Rupees Three Lakhs Twenty Thousand only) which was kept in my Almirah without informing anyone and thereafter she lodged a false complaint to the I.C., Bhaktinagar Police Station on 16.10.2023 and on the basis of the said complaint concerned police station has started a case against me, my old mother and unmarried sister being Bhaktinagar P.S. Case No. 923/2023 dated 16.10.2023 u/s 498-A/323/325/376/506/34 IPC.

I would like to further inform you that today my wife came to my house and told me to handover those purported copy of documents and she demanded a sum amounting Rs.20,00,000/-(Rupees Twenty Lakhs only) and she also threatened me to put my signature in an application for compromise decree of divorce which she brought with her but on refusal she assaulted me by fists and blows and she left my place and before leaving she again threatened me with dire consequences. The continuous illegal act of my wife, my matrimonial

status has already been ruined and her mother and second father are directly involved in all the commission of offence.

Under the above circumstances I would like to request you to investigate the matter and do the needful for the ends of justice.
