Subject : First Information Report

Respected Sir,

I, Smt Beauty Saha, Wife of Late Basudev Saha, resident of Sharat Chandra Pally, Haider Para, within Ward No. 40 of Siliguri Municipal Corporation, under P.S. Bhaktinagar, District Jalpaiguri would like to state that ~~29.1.24~~ ^{on 29.1.24} at around 8:15PM 1. Tapash Roy, 2. Gopal Das, 3. Samir Das, 4. Bulbul Dhar, 5. Pijush Sarkar and 10 others, Son of not known, resident of Sharat Ch Pally, near New Water Tank, ward No.40 along with some unknown miscreants arrived in front of our above addressed house and started to address filthy languages to my son namely Bikram Saha raising his father's i.e. my deceased husband's name and for querying about the said act, when my son went out of the house, they without spending any time started to beat him with deadly weapons viz. sharp knife, wooden sticks, bamboo sticks etc. On seeing the said attack, when I went to protect my son, they had also beaten me mercilessly with wooden and bamboo sticks and also one of the local friend of my son namely Subhodeep Debnath, Son of Bimal Debnath and Bappa Sarkar Son of Mohan Sarkar who also received physical injuries out of their said attack, it is to be referred that the said 1. Tapash Roy, 2. Gopal Das, 3. Samir Das, 4. Bulbul Dhar, 5. Pijush Sarkar attempted to stroke the knife towards my said son with an intent to murder him which he missed out of luck but out of the hits by the wooden and bamboo sticks, they tried to murder us. On our shout, the local people rushed at the spot and the said 1. Tapash Roy, 2. Gopal Das, 3. Samir Das, 4. Bulbul Dhar, 5. Pijush Sarkar along with his unknown miscreants left the place with a threatening of dire consequences to me and said my son. Out of the said attack, I along with my son and his said friend received severe bodily injuries and it is to be mentioned that during such attack, the said miscreants snatched my gold neck chain. I along with my said son and his friend had immediately been medically treated and are now under mental distress as well as under panic of harming our life and limb out of the desperate apprehending as well as already executed crime against us by the said 1. Tapash Roy, 2. Gopal Das, 3. Samir Das, 4. Bulbul Dhar, 5. Pijush Sarkar along with his unknown miscreants. It is right place to mention here that the said 1. Tapash Roy, 2. Gopal Das, 3. Samir Das, 4. Bulbul Dhar, 5. Pijush Sarkar is a well known miscreant of our locality who used to threat on earlier events to my said son to fulfill his illegal demand of extortion money.

So it would be kind enough, if you treat this present complaint as First Information Report and take immediate drastic action/s against the said 1. Tapash Roy, 2. Gopal Das, 3. Samir Das, 4. Bulbul Dhar, 5. Pijush Sarkar along with his unknown miscreants by imposing strict penal as well as other provision/s for the proper administration of Justice.
