## Sub: Formal Complaint against Bhawesh Gorkha for posting offensive content and harassment.

I Nirdoshika Tamang alias Sushma Tamang, daughter of Sri Dawa Tamang, presently residing at Laxmi Narayan Niwas, Sai Path 2, Parijat Road, Salbari, P. S. Pradhannagar, Dist. Darjeeling, a Facebook User bearing profile ID No https://www.facebook.com/subnir.pakhrinluksangmo.7?mibextid=ZbWKwL am writing to file a formal complaint against a Facebook user named Bhawesh Gorkha (Shawesh Bhujel) , Facebook profile link: https://www.facebook.com/profile.php?id=100093822158942&mibextid=ZbiWKwL, bearing phone number -7427979769, who is known to me and is in a friend list of my Facebook account, for posting explicit content tagging me without consent, which has led to severe defamation and harassment.

On 01/02/2024, Bhawesh Gorkha (Bhawesh Bhujel) intentionally uploaded a nude photo of a woman and tagged me with the caption."Hill media gone #nude for views." This reprehensible act has significantly damaged thy image, personality, and character. Since the post's appearance, I have been receiving random and disturbing calls from unidentified men, causing immense distress and concern for my safety.

Additionally, I would like to bring to your attention that It is within his knowledge that I belong to the member of the Scheduled Tribe community, his intentional act of insulting me on a social media platform by posting an objectionable image with a word "Nude" in the caption and tagging the content within public view constitutes an atrocity under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989.

Upon contacting Bhawesh Gorkha (Bhawesh Bhujel) and requesting the immediate removal of the post, he responded with threats of dire consequences and used vulgar language; further exacerbating the situation and violating my dignity be fold me Nepall language "तो नाङ्गे हिड्ने जान लाई नाङ्गे फोरो लाउँदा के हत्छ?" meaning that "You belong to Community that walk Naked, So what if I posted a Naked Photo."

Under the premises, I kindly request your prompt intervention and investigation into this matter. I believe that Bhawesh Gorkha's (Bhawesh Bhujel) actions not only breach social media guidelines but also constitute harassment and a threat to my well-being, committing an serious offence under The Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989, I seek the necessary legal actions and immediate arrest of this person who does not have any respect towards women.
