Dear Sir,

I, Sunil Kumar Mehta, Son of Sri Tej Narayan Mehta, Resident of Khanpur, Ward no. 01, Khanpur, Samastipur, Bihar – 848117, presently residing at C/O- Mr. Sushin Roy back side of Matigara police Station ,opposite Matigara Panchayat office, Matigara, Siliguri -734010, would like to inform you that I am the registered owner of Honda CB HORNET 160R motorcycle bearing Registration No. WB74AY4077 vide Chassis No. ME4KC23LDKA000474, Engine No.KC23EA4001107. Yesterday, i.e. 01.02.2024 at about 10 am when I was going to office by riding my aforesaid motorcycle near Maharaja Agrasen Hospital, Siliguri, after observing a red signal in the traffic point I stopped my motorcycle. While I was waiting for green signal all of a sudden a Truck bearing registration number WB73F9568 ignoring the traffic signal recklessly dashed my motorcycle at a high speed and as a result of which I fell from my motorcycle and I was severely injured. I was bleeding badly and I sustained severe injuries all throughout my body including my head and left leg. I got unconscious due to heavy impact of such sudden impact and grievous injuries. Later on gaining consciousness I found myself in Neotia Getwel Multi Specialty Hospital, Siliguri. Thereafter, I found that my ankle of the left leg was broken due to such deliberate jostle by the said truck. My ankle of the left leg is going to be operated today in the Neotia Getwel Multi Specialty Hospital, Siliguri. Till now, I am in a deep shock and trauma due to such attack of the said truck driver. I am in immense dilemma whether I will able to do my regular work in future. It is also pertinent to mention here that the said truck driver dashed me with a deliberate intention to kill me.
