I, SI Binup Mahato of NJP PS, Siliguri Police Commissionerate , do hereby lodge written complaint, on producing one arrested accused person namely Dhananjoy Roy (26) S/o Lt. Shib Nath Roy of Fulbari Bazar PS NJP Dist. Jalpalguri under arrest along with following seized articles;

1. 15 (Fifteen) Nos sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.

I am submitting a written complaint against the above noted accused person to the effect that today on 04.02.24 at 17-10 hrs myself alongwith C/1035 Sontosh Rabidas and CV-824 Niru Yadav left for performing Special evening Mobile duty vide NJP PS GDE No. 216 dt. 04.02.24. At 18-45 hrs received a secrete source of information that one person was selling Id Liquor illegally from his shop at Fulbari Bazar under NJP PS to its customers without any valid license. Accordingly I informed to the duty officer of NJP PS and also informed to O.C. NJP PS and as per his instruction myself alongwith force proceed towards Fulbari Bazar to verify the veracity of information. On arrival at the spot at 19-05 hrs on pointed out by the source it was found that one person was selling liquor illegally from his shop without name at Fulbari Bazar PS NJP to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered the above noted articles from his possession from his shop and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 19.05 hrs to 19.55 hrs. (seizure Total approx 9 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Dhananjoy Roy (26) S/o Lt. Shib Nath Roy of Fulbari Bazar PS NJP Dist. Jalpaiguri and arrange for its investigation.
