Sir,

In producing herewith one arrested accused person namely Mukesh Rajak (33 yrs) S/O Chandan Rajak of Netaji Nagar Colony, Ward No-46, PS- Pradhan Nagar, Dist.- Darjeeling Dist. Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

- (i) 13 (thirteen) bottles Kingfisher Strong Beer containing 650 ml in each bottle (Total 650 x 13 = 8.450 liters) and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1".
- (ii) 10 (ten) bottles of Old Monk XXX Rum containing 180 ml in each bottle (Total 180 x 10 = 1.800 liters) and marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit "B1".
- (iii) 08 (eight) bottles of Imperial Blue Blended Grain Whisky containing 180 ml in each bottle (Total 08 x 180 = 1.440 ltrs) and marked as Exhibit "C" out of which one bottle of the same taken as sample for examination and marked as Exhibit "C1".
- (iv) 06 (six) bottles of Magic Moments Grain Vodka containing 180 ml in each bottle (Total 06 x 180 = 1.080 ltrs) and marked as Exhibit "D" out of which one bottle of the same taken as sample for examination and marked as Exhibit "D1".

I, SI Bandhan Roy of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Mukesh Rajak (33 yrs) S/O Chandan Rajak of Netaji Nagar Colony, Ward No-46, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that today on 04.02.2024 at 20.15 hrs I received a specific source information that one person namely Mukesh Rajak of Netaji Nagar Colony, Ward No-46, PS- Pradhan Nagar, Dist.- Darjeeling is selling liquor in his shop situated at Netajee Nagar Colony under Pradhan Nagar Police Station without any valid license. Accordingly, I informed the matter to the I/C PS and diarized the fact in General Diary vide Pradhan Nagar PS GDE No 209, dated 04.02.2024 and as per your kind order and direction, I along with ASI Biplab Kr Das, ASI Monaj Kr Roy, C/1411 Ashok Roy, C/1413 Sujit Sarkar all of Pradhan Nagar PS left for Netaji Nagar Colony to verify the veracity of source information. On reaching there and as identified by the source I along with other officers and force conducted raid at the grocery shop of the above noted accused and managed to detain him. On being asked he disclosed his identity as noted above and also disclosed that he is storing illicit liquor illegally at his shop to sale the same in higher price for his wrongful gain. On being search the above noted seized articles were found in his shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 01 years for his illegal gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list from his possession and subsequently, arrested the above mentioned detained person namely Mukesh Rajak (33 yrs) S/O Chandan Rajak of Netaji Nagar Colony, Ward No-46, PS- Pradhan Nagar, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21.05 hrs to 22.05 hrs at the spot for violating the norms of Bengal Excise Act.

I therefore pray before your good self that a specific case may kindly be initiated against accused namely Mukesh Rajak (33 yrs) S/O Chandan Rajak of Netaji Nagar Colony, Ward No-46, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
