Sub: FIR regarding commission of an offence under section 135(1)(e) of Electricity Act 2003 (Amendment Act 2007) by Sri Vinay Kr Singh S/o Krishna Gopal Singh and section 150 abetment of Electricity Act 2023 by Sri Chandan Sarkar S/o Kshirmohan Sarkar, Vill- Namaru Jote, P.O- Gossainpur, P.S- Bagdogra, Dist Darjeeling on 05.02.2024 at 02.40 pm - 3.30 pm.

Dear Sir,

I, Sri Subhendu Chowdhury, (Aadhar no: 565548848198) S/O late Shardendu Chowdhury, AE & Station Manager, Shivmandir Customer Care Centre do hereby lodge this complain in favour of Sri Vinay Kumar Singh S/O- Krishna Gopal Singh and Sri Chandan Sarkar, Vill-Namaru Jote, P.O- Gossainpur, P.S- Bagdogra, Dist Darjeeling, has committed an offence by providing illegal extension of line from his premises to disconnected service connection of Sri Chandan Sarkar S/o Kshirmohan Sarkar, Vill - Namaru jote, P.O-Gossainpur, P.S-Bagdogra, Dist-Darjeeling. Sri Chandan Sarkar service line was disconnected due to non payment of OSD and he was enjoying the current from the illegal extension of line, which was provided by Sri Vinay Kr Singha. As such Sri Chandan Sarkar was too committed the offence under section 150 Abetment of Electricity Act 2003(Amendment Act 2007).

On 05.02.2024 at about 02.40 pm Sri Subhendu Chowdhury, S/O late Shardendu Chowdhury, AE & Station Manager, Shivmandir Customer Care Centre and other representative of WBSEDCL entered the premises of Sri Chandan Sarkar S/O Kshirmohan Sarkar, Vill- Namaru Jote, P.O- Gossainpur, P.S-Bagdogra Dist Darjeeling to inspect the service connection disconnected due to non payment of OSD. During inspection it was found Sri Chandan Sarkar S/o Kshirmohan Sarkar was illegally enjoying electricity by way of illegally extension of line provided by Sri Vinay Kumar Singh from his installed meter having SI no : BE0683520 against Con id-403069118 The electrical load found in the premises of Sri Vinay Kumar Singh during inspection was 1 Kw.

As unauthorized use of electricity was detected during inspection, the illegal arrangement was removed in the presence of witnesses and the aforesaid articles were seized at the spot by preparing a seizure list duly signed by Krishna Gopal Singh, father of Vinay Kumar Singh and Chandan Sarkar respectively. Also, the existing meter of both consumer were seized (meter details enclosed is Seizure list box) from the premises of the accused i.e Sri Vinay Kumar Singh and Sri Chandan Sarkar.

Since, Sri Vinay Kumar Singh, has committed an offence under section 135(1)(e) and Sri Chandan Sarkar has committed an offence under section 150 abetment of the Electricity Act 2003 (Amendment Act 2007), you are hereby requested to take cognizance of this complain and treat this complain as FIR.
