Sir,

In producing herewith one arrested accused person namely Manik Sarkar (40yrs) S/O- Shantu Sarkar of Upper Bhanu nagar, W.No-43, P.S-Bhaktinagar, Dist-Jalpaiguri along with following articles under proper seizure list-

1] 13(Thirteen) bottles of OYE OYE 70 UP country spirit (each bottle containing 300 ml) [Total 3900 ML/ 03 Ltr 900 ML]

I, SI Rantu Haldar S/O- Monoranjan Haldar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Manik Sarkar (40yrs) to the effect that today on 09/02/2024, received a source information that one person is selling liquor in his shop situated at near Cosmos mall under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with ASI Dipak Karmakar, C/374 Debraj Biswas, C/912 Nakul Chandra Singha left Ps at about 18.05 hrs for near Cosmos mall under Bhaktinagar PS to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no.418, dated-09.02.2024. On reaching there and as identified by the source it found that one person was selling and storing liquor in his shop situated at near Cosmos mall under Bhaktinagar PS. Subsequently, I along with officer and force cordoned the shop and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted bottles of liquor were found in his shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03 (Three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 19.15 hrs to 19.45 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person namely Manik Sarkar (40yrs) S/O- Shantu Sarkar of Upper Bhanu nagar, W.No-43, P.S-Bhaktinagar, Dist-Jalpaiguri after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Manik Sarkar (40yrs) S/O- Shantu Sarkar of Upper Bhanu nagar, W.No-43, P.S-Bhaktinagar, Dist-Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
