I, ASI Prasenjit Barman of Ashigarh Out Post, under Bhaktinagar PS/SPC would like to lodge this written complaint against the above-noted arrested accused person namely Suvodeep Roy (19 yrs.) S/O- Chabi Roy, of Fakdaibari, PO- Ghogomali, PS- Bhaktinagar, Dist.- Jalpaigurito the effect that today on 09/02/2024 at 19:00hrs. I, received source information that one person is selling liquor in his lottery shop situated at Fakdaibari more without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashigarh Out Post GDE No 274, Dated 09/02/2024, and shared the information with O/C Ashigarh OP. As per his kind direction I, along with forces of Ashigarh OP had been to Fakdaibari more to verify the integrity of the information in hand. On reaching there and as identified by the source we held a raid at the lottery shop of the above-noted accused person and managed to apprehend him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. On further search, the above-noted seized articles were recovered from his lottery shop. On-demand he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, he stated that he had been involved in selling and possessing liquor without any valid license for the last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested the abovementioned person named Suvodeep Roy (19 yrs.) S/O- Chabi Roy, of Fakdaibari, PO- Ghogomali, PS- Bhaktinagar, Dist.- Jalpaiguriafter observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19:30hrs. to 19:50 hrs.

Under the above-noted facts and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Suvodeep Roy (19 yrs.) S/O- Chabi Roy, of Fakdaibari, PO-Ghogomali, PS- Bhaktinagar, Dist.- Jalpaiguri under the proper section of the law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
