In producing herewith one accused person namely Mosha Mondal (M/36yrs) S/o- Mijanur Mondal of Debidanga, Middle Palash, PS- Pradhan Nagar, Dist- Darjeeling along with the following seized articles as per proper seizure list:

1. 08 (Eight) sealed plastic Bottles of HIMALAYAN GOLD 60 UP India made liquor each bottle containing 600 ML
2. 08 (Eight) sealed plastic Bottles of KACHI India made Liquor 70 UP each bottle containing 300 ML

With due respect and humble submission, I ASI Debasish Das S/O- Haripada Das of Siliguri PS under Siliguri Police Commissionerate do hereby lodge this written complain after producing herewith the above-noted seized articles to the effect that on 09.02.24 at 18.15 hrs while performing Plain Cloth patrolling duty received source information that one person namely Mosha Mondal was selling liquor in his shop situated at Lichu Bagan under Siliguri PS/SPC, for his wrongful gain without any documents/license. Diarized the fact in GD vide Siliguri PS GDE No- 471, dated 09.02.24. As per your kind instruction myself along with force left for the PO to work out the information. At 18.55 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid at the shop of the above-noted accused person and able to detain one person, who disclosed his identity as noted above. On being searched the above-noted bottles of liquor recovered from his shop. Further, being asked he confessed that he is doing the business of selling and storing liquor in his shop since long for his wrongful gain without any valid documents/license. Then, in the presence of available witnesses, namely i) Bikram Ghosh (M/26 yrs) S/O- Prolhad Ghosh Of Subhas Pally, Rail quarter W/No-18, PS- Siliguri, Dist-Darjeeling, Ph no- 9593226645 (ii) Sushil Sarkar (M/35 yrs) S/O- Lt. Sadhan Sarkar Of Liuchu Bagan, Subhas Pally, W/No- 18, PS-Siliguri, Dist-Darjeeling I seized the above-noted articles from the PO after prepared proper seizure list. (The seizure was made in between 19.25 hrs to 19.55 hrs). As he has violated the rules and norms of Bengal Excise Act. I arrested the apprehended accused person namely Mosha Mondal (36yrs) S/o- Mijanur Mondal of Debidanga, Middle Palash, PS- Pradhan Nagar Dist- Darjeeling after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Mosha Mondal (36yrs) S/o- Mijanur Mondal of Debidanga, Middle Palash, PS- Pradhan Nagar Dist- Darjeeling under proper section of law and arrange for investigation.
