Would like to draw your kind attention to the following effect that on 4th February $^{\circ}$ 2024 at around 6:30 – 07:00 PM the aforesaid Deepak Barman & his wife i.e., Monalisa barman, Dipika Barman, D/o Deepak Barman and Mamani Barman came in the house my Son-in-Law i.e., Natun Para, Jalpai More, 5th Mahananda bridge, P.O. Siliguri Bazar, P.S. Siliguri, Dist- Darjeeling 734005. And told me that one Dipika Barman narrated them my son in law i.e., Md. Mansur Alam rebuked her even slapped her on 03/02/2024 at about 03:20 PM in the house of my son in law when she came there for the guidance/studies purpose for her examination without any fees at that time my daughter namely Rupshad Begam was also there but my daughter did not protest her husband for which she sustained severe mental pain, agony and since then she is weeping and did not take any food. At that time my son in law was not there for which my daughter called her over phone and she informed my daughter he would be available in 20 to 25 minutes. Thereafter said Deepak Barman, and his wife Monalisa Barman and Mamani Barman left the house of my son in law. Accordingly, my son in law came his house at about 08:30 PM thereafter the aforesaid persons forcibly entered into the house of my son in law with a ferocious mood and used to start ransack the house and also hurling dirty languages for which my son in law appeared there then the aforesaid person except female person pushed him in a room and the aforesaid persons also went inside and locked the door with a plea that the aforesaid persons want to have some talk with him. During the meantime suddenly there was sounding hue and cry of my son in law from the said room for which my daughter and others who present there knocked the door for which the aforesaid persons opened the door and we saw my so in law is in lying on a semi unconscious condition on the floor and profuse bleeding was oozing from his nose and entire room and clothes are blood in blood of my son in law then the aforesaid persons attacked my daughter Rupshad Begam and threatened her by delivering of Rs. Two Lakhs immediately otherwise they will kill my son in law and the aforesaid persons assaulted us with fist and blow when my said daughter refused to give money then they outrage the modesty of her and

they also tried to set fire on the house of my son in law and they also tried to kill my son in law with intention to kill him by assaulting him with a stick and other materials upon his nose. Gradually some local peoples were appeared there then they fled from there. Thereafter an Ambulance was called for and took my son in law in Anandaloke Hospital, Sevoke Road, Siliguri wherefrom he was discharged from on 08/02/2024, but the daughter of said Dipak Barman lodged a written complaint with false and concocted story against my son in law with Women P.S. Siliguri for which my son in law has been arrested today and presently he was in J/C.

It is pertinent to mention that the aforesaid persons also stolen one gold chain from the neck of my daughter. The aforesaid persons hatched up a deep-rooted conspiracy to extort the money from my son in law.

Some unintentional delay is appeared to lodged this complaint due to the treatment

In view of the above you are requested to look in to the matter by proper investigation and booked the culprits as per law.
