Sir,

In producing herewith one (01) accused person named Netai Rajbanshi @ Pocha (M/24), S/O- Gajen Rajbanshi of Ektiasal, Assam Colony, PS- Bhaktinagar, Dist- Jalpaiguri under arrest along with following seized articles;

- (i) One iron made improvised Fire Arms having its trigger, hammer and firing pin measuring approx 10 Inch including its butt, body and barrel [The articles have been found kept concealed on back side of waist of accused Netai Rajbanshi @ Pocha & marked as 'Exhibit-A'']
- (ii) One (01) numbers of live ammunition inscribed as "8 MM", "KF" on percussions cap of ammunition kept inside Right pocket of Jeans Pant of accused Netai Rajbanshi @ Pocha & marked as 'Exhibit-B'

I, SI Basudeb guha of Bhaktinagar PS, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person to the effect that today on 10.02.2024 at about 16.45 hrs received a secret information from my secret source that one person had been waiting at back side of Payal Cinema Hall, Sevoke Road under PS- Bhaktinagar for committing heinous crime and he used to carry and possess small arms & ammunition with him. Accordingly I requested him to came and identified the accused. Wasting no time, I diarised the information in Bhaktinagar PS General Diary Book vide GDE NO- 532, Dated 10.02.2024 and consequently informed the tip off to you for kind instruction. Subsequently, on being directed, I along with ASI- Chandra Prakash Adhikary, ASI Dipak Karmakar, C/674 Debraj Biswas, and CV/619 Dharmendra Roy left Bhaktinagar PS for perusing the information by Govt. Vehicle. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

We reached at back side of Payal Cinema Hall under PS- Bhaktinagar at 17.15 hrs and contacted two independent witnesses namely i) Suman Sarkar(M/35), S/O Subal sarkar of Bidya chakra Colony, W/No-44, PS- Bhaktinagar, Dist- Jalpaiguri and ii) Sandip Rai(M/37) S/O Lt. Prem Bahadur Rai, Salugara Bazar, PS- Bhaktinagar, Dist- Jalpaiguri and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Subsequently, after contacting my secret source and being informed and identified I along with my accompanied officer and force conducted raid at back side of Payal Cinema Hall, in presence of witnesses and apprehended the above noted accused person named Netai Rajbanshi @ Pocha as identified by my secret source. Searched him immediately and found the above noted articles from his conscious and exclusive possession kept concealed in his back side of his waist under cover of his wearing apparel.

Subsequently, being interrogated, the apprehended accused person disclosed his identity as noted above. Further being interrogated he admitted that he has collected the said Fire Arms and ammunitions from Bihar. On demand he failed to produce any document in support of his possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused named Netai Rajbanshi @ Pocha exclusively & consciously possessed this improvised fire arms with live ammunitions illegally with some ill motives.

Thus, when his involvement in carrying and possessing illegal fire arm established, I seized and labelled the above noted articles at the spot under proper seizure list duly signed by him as well as by the above noted independent witnesses and also put my signature on the seizure list and label. I also arrested him preparing memo of arrest informing him ground of his arrest.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused Netai Rajbanshi @ Pocha has carried the said fire arms with live ammunitions with an objective to commit heinous crime in the locality.

So, I pray before you for starting a case against Netai Rajbanshi @ Pocha (M/24), S/O- Gajen Rajbanshi of Ektiasal, Assam Colony, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law as he has wilfully violated the regulation of Arms Act and for arranging its investigation.
