In producing herewith the 01 (One) arrested accused person namely (Aviabatile) Solargor Ali of Atal T.G. Tinline, PO Hatighisha, PS Naxal Bari, Dist. Darjeeling (Not verified) along with the following seized articles under proper seizure list :-

 One packet of plastic back colour pouch containing Total 91 grams [ninety one grams] Approx of suspect to be Brown Sugar marked as Exhibit-"A".

(ii) One light blue colour mobile phone styled as POCCO with SIM vide No. 83719 26535

I, SI Samik Paul of Bagdogra Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted 01 (One) arrested accused person to the effect that today 09.02.2024 at about 14.10 hrs I received a specific source input that one person was coming from Panitanki Side with huge quantity of Brown Sugar for delivering the same to their designed customers. The matter was diarized vide BDR PS PS GDE No. 443 Dt. 09.02,2024 and I informed the matter over messanger to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Md. Munna Ahamed. C/ 1509 Sourov Roy Sarkar, all of BDR PS, Siliguri Police Commissionerate being headed by me left for Sighijhora by govt. vehicle with investigation kit to verify the veracity of the information in hand vide BDR PS GDE No 444 dated 09.02.2024 and M.C.C. No. 75/2024 dated 09.02.2024. In the mean time I also informed the Van Officer ASI Jahangir Ali of Bagdogra PS, Siliguri Police Commissioneratre, to accompany us. Further I also informed the Videographer namely Hari Barman (27) s/o Kalidas Barman of Rupsinghjote, PS Bagdogra, Dist. Darjeeling to be present at Sighijhora to prepare the Video of whole process of search and seizure if any. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 14.30 hrs we arrived at Singhijhora on the way to the spot, I called two independent witnesses namely (i) Md. Ramjan (24) s/o Lt. Md. fakira of Bhujiyapani, PS bagdogra, Dist. Darjeeling and (ii) Kundan Roy (24) s/o Prem Kumar Roy of Khudiram Pally, Lower Bagdogra, PS Bagdogra, Dist. darjeeling and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that one person was coming from Panitanki Side which was matched with our information. Accordingly, we intercepted said person who disclosed his identity as noted above.

After disclosing our identity, we detained the above noted person with a strong reason to believe that he illegally possessing brown Sugar in his possession kept in his left pocket of his wearing Jacket which he carrying for selling the same to his designed customers for his wrongful gain. On being asked he confessed that he possessed brown Sugar in his possession. I then gave him option in writing whether he wanted to be searched in presence of Executive Magistrate or by any Police Gazetted Officer. Then he agreed to be searched by any one of them. Further, I served him Notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the apprehended person to search our Police Party as per provision of law but they denied searching police party. Accordingly, I informed the matter to the Officer-In-Charge, BDR PS and as per his kind order I informed the fact to Shri Suraj Thakui, WBPS,, Assistant Commissioner of Police, Head Quarter, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day regarding the interception of the one person suspected to be possessed of Brown Sugar and requested him to come to the spot and to supervise the search and seizure being a gazette officer. Accordingly at 17.05 hrs Shri Suraj Thakui, WBPS, Assistant Commissioner of Police, Head Quarter, Siliguri Police Commissionerate arrived at the spot and accordingly, I disclosed his identity to the detained person as Special Executive Magistrate of Siliguri Police Commissionerate. Then In presence of Shri Suraj Thakui, WBPS,, Assistant Commissioner of Police, Head Quarter, Siliguri Police Commissionerate detailed as Special Executive Magistrate and two independent public witnesses searched the detained person following all formalities and recovered 1) One packet of plastic back colour pouch

containing Total 91 grams [ninety one grams] Approx of suspect to be Brown Sugar marked as Exhibit-"A". 2) One light blue colour mobile phone styled as POCCO with SIM vide No. 83719 26535. On demand in presence of the Shri Suraj Thakui, WBPS, Assistant Commissioner of Police, Head Quarter, Siliguri Police Commissionerate he failed to produce any valid document in support of possessing of the brown sugar which he was carrying as well as without valid documents.

Thereafter, I weighted One packet of plastic back colour pouch suspect to be Brown Sugar in presence of Shri Suraj Thakui, WBPS, Assistant Commissioner of Police, Head Quarter, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day and the independent witnesses with the weighing instrument and found total 91 grams [ninety one grams] Approx of suspect to be Brown Sugar marked as Exhibit-"A". Further, on demand in presence of Shri Suraj Thakui, WBPS, Assistant Commissioner of Police Head Quarter, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day as well as independent witnesses the above noted detained person failed to produce any valid documents in support of possessing of Brown Sager. Thus when his involvement in carrying and possessing brown sugar was established, then I seized the above noted articles from the exclusive possession of the above noted accused person at the spot at Singhijhora more PS BDR, Dist.-Darjeeling under proper seizure list in presence of Shri Suraj Thakui, WBPS, Assistant Commissioner of Police, Head Quarter, Siliguri Police Commissionerate acting as Special Executive Magistrate, of SPC for the day as well as independent witnesses as noted above and acknowledged by the accused person and marked the seized articles as Exhibit-"A". Subsequently, I labeled the seized articles in presence of Shri Suraj Thakui, WBPS, Assistant Commissioner of Police, Head Quarter, Siliguri Police Commissionerate and independent witnesses and accused person as noted above. The whole process of seizure was made in between 17.10 hrs to 17.35 hrs on 09.02.2024. On further asked they confessed in presence of Shri Suraj Thakui, WBPS, Assistant Commissioner of Police, Head Quarter, Siliguri Police Commissionerate acting as Special Executive Magistrate and other witnesses that he has been dealing in such business of selling the brown sugar illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Amjad Ali (42) s/o Ajgor Ali of Atal T.G. Tinline, PO Hatighisha, PS Naxal Bari, Dist. Darjeeling (Not verified) is involved in procuring and selling of Brown Sager illegally and contravening the normal of NDPS Act was established, Then, I arrested the above noted accused person after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. The whole process of Search, seizure Lebelled and arrest was made in-between 17.05 hrs to 17.45 hrs on 09.02.2024.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the above noted arrested accused persons namely Amjad Ali (42) s/o Ajgor Ali of Atal T.G. Tinline, PO Hatighisha, PS Naxal Bari, Dist. Darjeeling (Not verified) and arrange for its investigation.
